Changes to Jefferson Parish Bidding Information

The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:

Bidder acknowledges that Bidder recovered the cost of any required insurance in the contract price as required by La.R.S. 9:2780.1 and that Bidder recovered any such cost for the purposes of insuring an obligation to indemnify Jefferson Parish, defend Jefferson Parish, or hold Jefferson Parish harmless and that Bidder's indemnity liability is limited to the amount of the proceeds that are payable under the insurance policy or policies that Bidder has obtained.

Electronic Procurement: Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. Central Bidding can be accessed by visiting either www.centralbidding.com or www.jeffparishbids.net. All bidders will be required to register with Central Bidding. Probable Construction Cost: Per Jefferson Parish Administrative Policy, the probable construction cost is not revealed in the Jefferson Parish Bidding Documents. Heavy Duty Barricade Specifications

1. Barricades are hot-dipped galvanized after welding to ensure a rust-free life. Barricades are shipped fully assembled, inspected and ready to use.
2. **Overall height-** 43" including feet, with no more than 11.5" gap under bottom rail.
Overall length- 8'7" included connectors, overall length approx. 8'5" when interconnected.
Weight- 57 lbs.
Main frame- The top and bottoms rails of the barricades shall be made of 1 ½" O.D. 16 gauge steel tube. Steel wall thickness shall be minimum 0.065" steel tubing, per ASTM A513 TYPE 1 MT1.
Grille: Grill shall be composed of 19 equally spaced vertical members of 5/8" O.D. 16 gauge steel tubing, of same materials as above. Vertical members shall extend into main frame 3/4" and welded top and bottom.
Locking- Product shall be designed with male-female interlocking ends. Barricades shall join and unlock at only one position (30 degree angle). The male locking device shall have a minimum diameter of 5/8" and be made of solid steel rod then welded through the main frame at both ends. The female locking device shall be made of 3/16" thick X 1.5" plate U-shaped to receive male device at 30* angle only. Locking devices shall be near top and bottom rails of frame to prevent their use as a step when connected to adjacent barricades.
Feet- Barricades shall have two (2) bolt-on replaceable feet ½" X 2" flat steel bar with 1 ¼" OD 14 ga. Stem inserted and secured with 3/8" grade 5 bolt with vinyl-lock nuts.
Finish- After all fabrication product shall be hot-dipped zinc-galvanized conforming to Marine specifications.
Delivery- Barricades are delivered ready to use (not palletized.)
3 step inspection process ensures that:
 1. The feet are bolted on correctly.
 2. The barricades are leveled.
 3. The barricades are free from galvanizing burrs.

(for all awarded contracts related to "mechanics and laborers" with a value greater than \$100,000.00)
