**1.0 GENERAL**

The bidder shall supply three (3) - Aurora Model 611SF SPHER-FLO Non-Clog, horizontal, Dry Pit pumps, or approved equal. Pump size is 10 X 10 X 15, of all iron construction, pump only. Pumps shall have a capacity of US 2500 GPM at 17 feet, total head at 700 RPM with a temperature of 60° Fahrenheit, 1 specific gravity. The units shall be designed for RAS. The pumps specified are replacing those already in service, and must fit on existing bases, and utilize the existing motors, coupling, and piping with no modifications. The units shall be provided by authorized factory representative for Jefferson Parish, Louisiana, and for the brand being offered. Any bids submitted for manufacturers, other than that is specified, must include in their bid all information needed to fully demonstrate complete compliance with requirements of these specifications and dimensional duplicity of the existing units. The bid will be awarded to the lowest responsible bidder complying with all provisions of this invitation, providing the bid is reasonable, and in the best interest of Jefferson Parish to accept. Jefferson Parish reserves the right to accept or reject any bids that are incomplete or do not demonstrate that they are equal to the requirements of these specifications. It is the bidder's responsibility to provide adequate information necessary for the complete evaluation of their proposed equipment. Jefferson Parish shall be the sole judge as to the equality of any alternate manufacturer's offering.

**2.1 PUMP CASING**

The pump casing shall be of the top centerline design and will be constructed of "APCO-Loy 33," and shall be of sufficient thickness to withstand stresses and strains at full operating pressures. Casings shall be subject to a hydrostatic pressure test of 125 lbs. A minimum size handhole 3 inch x 5 inch is to be provided in each casing for cleanout purposes. The casing design shall allow front or rear impeller pullout.

**2.2 BEARING HOUSING**

The bearing housing is to be of cast iron and shall be furnished with a set of regreaseable bearings for both radial and thrust loads. The bearings shall have an average life of 100,000 hours and shall be mounted in a machined, moisture and dustproof housing. The housing is to have register fits and then be bolted to the pump

casing to ensure permanent alignment. A Durometallic CRO, double seal, carbon vs durchome mechanical seal shall be provided. Connections for water sealing from an outside source shall be provided by customer for water flush through the seal. A drain opening must be provided to facilitate removal of lubricating liquid.

**2.3 IMPELLER**

The impeller shall be of the enclosed type with wiper blades located on the back shroud to prevent accumulation of solids behind the impeller. The vanes shall be skewed to reduce noise. The impeller is to be of "APCO-LOY 33" and shall be capable of passing a minimum sphere size of 4-3/4 inches. The impeller shall be dynamically balanced before assembly into the pump and shall be securely fastened to the shaft by means of a stainless-steel key and impeller locknut. Axial adjustment of the impeller is to be external.

**2.4 PUMP SHAFT**

The pump shaft shall be constructed of high-grade carbon steel, having a tapered impeller extension and accurately machined. The minimum diameter acceptable will be 3-1/2 inches. The pump shaft shall be protected from wear by a corrosion and wear resisting hardened stainless-steel shaft sleeve, having a 450 minimum Brinell hardness. An O-ring type gasket must be provided between the impeller hub and the shaft sleeve to prevent pumped liquid from corroding the shaft.

**3.0 CONDITIONS OF SERVICE**

The following conditions of service shall be strictly adhered to:

- Discharge Size ..... 10 inch minimum
- Suction Size ..... 10 inch minimum
- Sphere Size ..... 4-3/4 inch minimum
- Design Capacity .....2500 GPM
- Design Head ..... 17 feet
- Rotating Speed .....700 RPM maximum

**4.1 SERVICE**

The pump manufacturer shall have a direct factory service center/stocking facility capable of completely servicing, and which stocks identical spare parts for the proposed pumps. The System Supplier shall be an Authorized Distributor of the proposed products and shall be capable of a form of direct responsive communication within a two (2) hours notification in regards to service requests and parts availability.

**4.2 WARRANTY**

The pump manufacturer shall provide a written prorated warranty against defects in material and workmanship for a period of at least five (5) years or 5,000 operating hours, under the operating conditions specified for the units supplied, in accordance with their standard published Municipal Pump Warranty. Pump manufacturer shall demonstrate ability to support claimed warranty coverage by meeting all requirements of this specification.

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.
