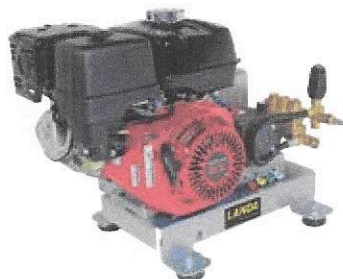

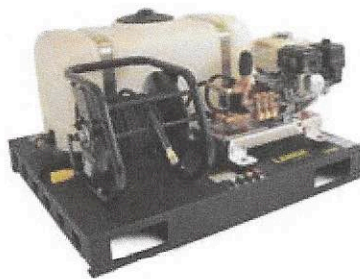

HD 4.0/40 GB shown with optional skid mount feet




HD Direct Drive shown with optional HD Pallet Skid with Tank
