Digital Magazine Service

Zinio is a service that allows public libraries to grant patrons access to full digital issues of selected magazines via a digital catalog, with use of a library card.

Magazines are digital copies of print originals and contain the same content.

Patrons can log into their account via app or web browser anywhere with internet access. Issues can be downloaded and read offline.

The entire content is available on servers hosted by Recorded Books.

The Personal Viewer Account is where downloaded magazines are stored. The patron keeps the issues they have downloaded and there are never any holds, checkout periods, or maximum quantities.

The Library Collection Account enables the patron to fully access the Zinio collection and check out any title indefinitely. This account is also where the latest issues of each magazine are located for checkout.

Both accounts are required to properly access Zinio for Libraries.

The Personal Viewer Account enables the patron to read their checkouts on or offline via multiple devices. In order to see which devices are compatible in this account, the patron can change the view from the magazine cover to the List View and a list can be viewed with compatible apps.

Zinio has over 2,221 magazines in their online catalog and titles and publishers are being added on a regular basis.

Patron can download a free App to their desktop or mobile device to view the magazine issues offline after downloading the issue to the App. Direct links to the Apps may be found on the "My Library" screen in the Zinio.com Personal Viewer Account or through your Apps stores.

Zinio is compatible with PC's and Mac's as well as iPhone, iPad, Android, Kindle Fire, and Blackberry Playbook.

Zinio support is available 24 hours a day seven days a week at 877-772-8346 by email at [yourrbdigitalsupport@recordedbooks.com](mailto:yourrbdigitalsupport@recordedbooks.com). There is online training via webinar for further support.

Our reporting options for statistics include number of accesses and logins, magazines viewed by title, and average time per each title. Marketing tools are available for download from our website. They include posters, bookmarks, fliers, and shelf talkers.
