By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 136353 and/or Resolution No. 141125 as amended. All vendors submitting bids should register as a Jefferson Parish vendor if not already yet registered. Current W-9 forms with respective Tax Identification numbers and vendor applications may be submitted at any time; however, if your company is not registered and/or a current W-9 form is not on file, vendor registration is mandatory. Vendors may experience a delay in payment if your company is not a registered vendor with Jefferson Parish.

Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. Bidders are required to complete, sign and return the bid form and/or complete and return the associated line item pricing forms as indicated. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit prices shall prevail.

JEFFERSON PARISH reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of JEFFERSON PARISH. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)

JEFFERSON PARISH reserves the right to cancel all or any part of an order if not shipped promptly. No charges will be allowed for parking or cartage unless specified in the quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel at any time and for any reason by issuing a THIRTY (30) day written notice to the contractor.

JEFFERSON PARISH requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(l), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. PRINTING OF ELECTION POLL LIST SHEETS

Scope:

- We extend this bid to provide all labor, materials, delivery, equipment, and all other incidentals necessary to provide POLL LIST SHEET Printing for the Jefferson Parish Registrar of Voters Office, Joseph S. Yenni Building, Suite 502, 1221 Elmwood Park Blvd, Jefferson, LA 70123, for a period of (36) months.

Quantities:

- Quantities are not guaranteed. The amount of POLL LIST SHEETS will vary, predicated on the size of the election and participating voters. Printed may be needed but not limited to four (4) times a year, with an estimated page count of (but not limited to) 20,000 pages of printing for each election.

Bid Specifications:

Vendor shall perform and/or provide the following:

- Successful vendor must sign a non-disclosure agreement before a contract is awarded.
- Successful vendor shall have an email address to receive printing notifications from the Louisiana Secretary of State's office and/or the Jefferson Parish Registrar of Voters office.
- Successful vendor shall use a Secure File Transfer Protocol (SFTP) client for the secure download of Poll List data.
- Successful vendor shall have to create a PGP key, send the Secretary of State the public key, and decrypt the encrypted PDF files after download.
- Successful vendor shall pack the print jobs according to the Jefferson Parish Registrar of Voters Office specification.
- Successful vendor must permanently destroy all Post List PDF files after printing from any computer or device used in the process, and must shred all misprints.
- Successful vendor will be solely responsible for the final product and for meeting all scheduled delivery dates and times.
- Successful vendor shall provide a sample Poll List Sheet printout before a contract is awarded. Provide Poll List Sheet printing as needed for each election held in Jefferson Parish.
- Data shall be printed in the order it is received.
- Vendor will receive a notification from the Jefferson Parish Registrar of Voters Office the day after Early Voting is completed. This will include Saturdays, Sundays, and Holidays. Vendor shall provide a contact person and a mobile phone number to receive these notifications. Answering services cannot be used for this contract.

- The items should be packed so that the pages do not get out of order, and the recipient can easily pull each PDF file from the packing box for placement in binders.
- Printed data will be verified against the PDF file.
- All data obtained from the Secretary of State must be removed from the successful vendor's premises. Data must not be transferred to removable media, and may not be shared with a third party.
- Successful vendor shall itemize each bill per election. The page count on the invoice must match the number of pages ordered. Payment will not be issued for reprints due to vendor error. There will be no payment for overruns or minimum quantities.
- Cost per election will vary due to the quantity of POLL LIST SHEETS printed.
- Due to the complexity, safekeeping, and Importance of this work, the successful vendor shall have a printing site within a maximum of a one-hour drive from the Jefferson Parish Registrar of Voters Office to allow for inspections as needed.

Key Points to Ensure Compliance:
