



AGREEMENT, made this 31 day of January 2020, by and between GLOBE TRAILERS., a corporation organized under the laws of Florida, hereinafter called "GLOBE", and Old River of New Orleans, LLC hereinafter called "DEALER".

SECTION I: DEALER PROGRAM

Globe grants Old River of New Orleans, LLC / DBA Old River Truck Sales the right of sale of Globe Trailers products in the area of responsibility described in Section II. Globe reserves the right to sell direct to the Federal Government & GSA customers. Dealer may also sell to the Federal Government & GSA customers.

SECTION II: AREA OF RESPONSIBILITY

Old River of New Orleans, LLC / DBA Old River Truck Sales has St. Rose / New Orleans territory.

SECTION III: AREA OF RESPONSIBILITY REQUIREMENTS

To maintain an area of responsibility the dealer must purchase a minimum of 500,000 dollars per year.

SECTION IV: DURATION

This Agreement shall be 12 months at which time the Agreement will renew. Either party may terminate this Agreement by giving to the other notice in writing (30) days in advance, but any termination of this Agreement, for any cause, shall not release the Dealer from paying his account in full in accordance with the provisions of this Agreement.
