**Banner Arm Set:**

The banner arm set per each shall include 2 - ¾" diameter black fiberglass arms with aluminum end caps and associated mounting hardware. Brackets shall be spring loaded and any size or shape (round, square, fluted) pole. Brackets and arms shall be designed to accommodate banners up to 20 sq. ft. and work with any arm length. The 24" Banner Arm set is for a 24" wide banner with the 28" Banner Arm used for a 24" wide banner. Banners to be supplied by others.


