2. Stipulated Damages:

- 2.1 Bidder agrees to pay as damages the sum of \$100 per day for each consecutive workday that demolition and clearance work at a specific work site is not substantially complete beyond the time noted in the Bid Form for Key Time Periods.

3. General Statements:

- 3.1 Bidder, having examined the Contract Documents and the site(s) of the proposed work and being familiar with all of the conditions surrounding the proposed project hereby proposes to perform the work in accordance with the Contract Documents for the price stated in this bid.
- 3.2 The specifications and any addenda are complementary of each other. What is called for by one shall be as binding as if called for by all. If a conflict between any of the above is discovered by the CONTRACTOR, the problem shall be referred to OWNER in writing as soon as possible for resolution. Should a conflict occur which is not documented in writing and resolved before bid time and/or is necessary to comply with mandatory requirements (i.e. codes, ordinances, etc.), it shall be the CONTRACTOR's responsibility to price and bid the more expensive method.
- 3.3 If a bid is accepted for a specific work site, Bidder will sign the Agreement and other documents required by the Contract Documents within five (5) days after the date of OWNER's Notice of Award.

4. Representatives, Warranties, and Certifications:

- 4.1 In submitting this bid, Bidder warrants and represents that:
- A. Bidder has familiarized itself with the Work required by the Contract Documents, the site where the Work is to be performed, local labor conditions and all laws, regulations, and other factors affecting performance of the Work, and having satisfied himself of the expense and difficulties attending performance of the Work.
- B. Bidder has obtained and carefully studied (or assumes responsibility for obtaining and carefully studying) all appropriate examinations, investigations, explorations, tests, and studies (including existing underground facilities at or contiguous to the site(s)) which pertain to the physical conditions at the site or otherwise may affect the cost, progress, performance, or furnishing of the Work, and no additional examinations, investigations, explorations, tests, reports or similar information, or data are or will be required by Bidder for such purposes. Bidder assumes responsibility for the accuracy of the foregoing.

- C. Bidder has correlated the results of all observations, examinations, investigations, explorations, tests, reports, and studies with the terms and conditions of Contract Documents.
 - D. Bidder has given OWNER written notice of all conflicts, errors or discrepancies that it has discovered in the Contract Documents and the written resolution thereof is acceptable to bidder.
 - E. The bid is genuine and not made in the interest of or on behalf of any undisclosed person, firm, or corporation and is not submitted in conformity with any agreement or rules of any group, association, organization, or corporation; bidder has not directly or indirectly induced or solicited any other bidder to submit a false or sham bid; bidder has not solicited or induced any person, firm, or a corporation to refrain from bidding; and bidder has not sought by collusion to obtain any advantage over any other bidder or over OWNER.
 - F. Other than the payment of their normal compensation to person regularly employed by the bidder whose services in connection with the project were in the regular course of their duties for Bidder, Bidder has not employed any person, corporation, firm, association, or other organization, either directly or indirectly, to secure the contract; and no part of the contract price to be received by bidder has been or will be paid to any persons, corporation, firm, association, or other organization for soliciting the contract.
 - G. Neither Bidder nor anyone affiliated with Bidder has divulged information regarding said bid or any data relative thereto to any other person, firm, or corporation.
 - H. This bid is not intended to secure an unfair advantage or benefit from the OWNER or in favor of any person interested in the proposed contract.

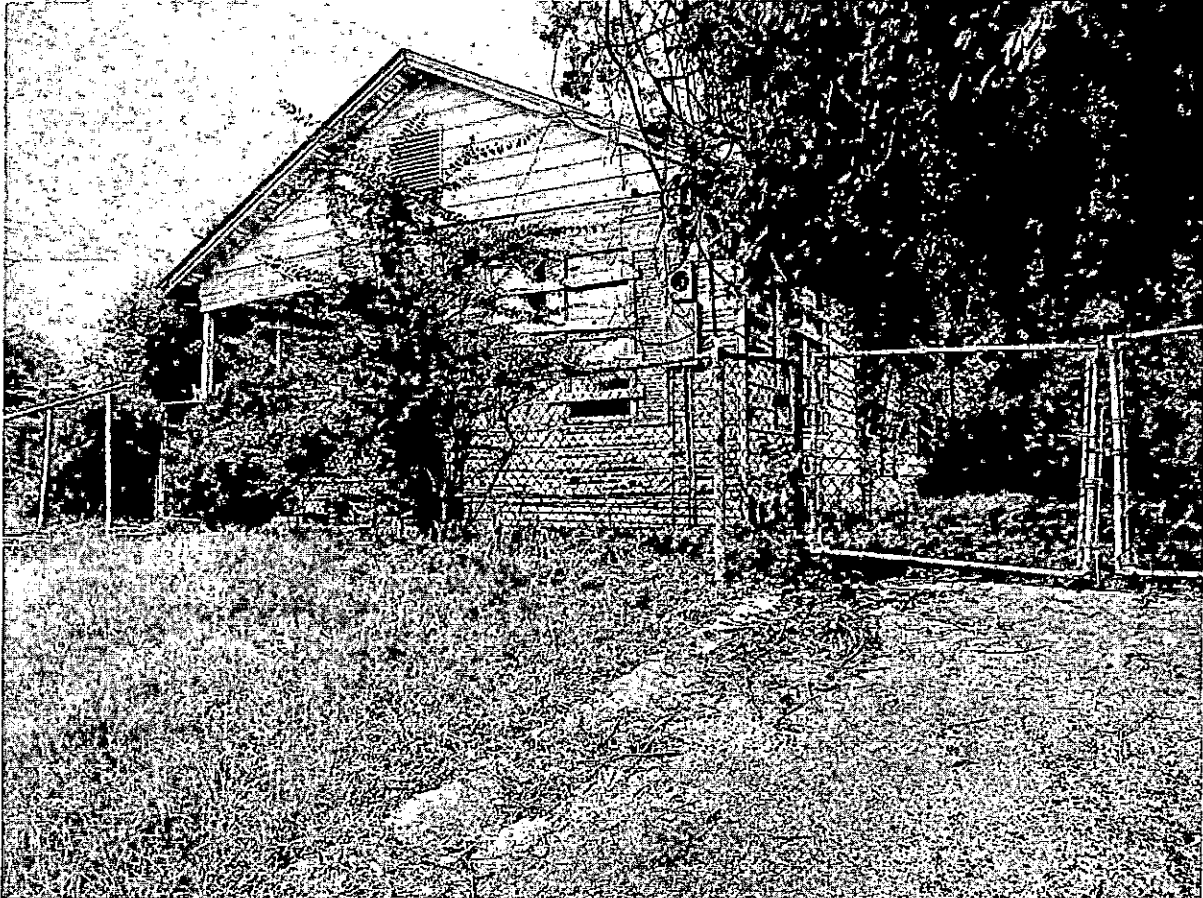
