The Purchasing Director will review it in connection with the Parish Attorney's Office as appropriate and a written response will be provided as soon as possible.

JEFFERSON PARISH reserves the right to cancel all or any part of an order if not shipped promptly. No charges will be allowed for parking or cartage unless specified in the quotation. The order must not be filled at a higher price than quoted. We extend this proposal to cover all labor, materials, and necessary essentials for removing existing carpet and supplying & installing new carpet for The Department of Public Works Rehab. Removing old VCT tiles and installing new VCT tiles in required areas.

**Section 5.0 – Bid Specifications:**

The successful bidder shall supply all labor, materials, and necessary essentials to perform the following at the Rheem Building, 4901 Jefferson Highway, Suite E, Jefferson, LA 70121

- Remove existing carpet tile in front left office and large area to be subdivided on opposite side of hallway. Supply and install approximately 1,700sqft of new carpet tile to match as close as possible to original in same areas except vestibule from hallway to break room. Supply and install approximately 200sqft new VCT tile in vestibule from hallway to break room to match as close as possible to existing VCT tile. Includes new 4" cove base in same areas. Includes a small amount of VCT patch near first office in front left.

**Section 6.0 – Cleaning Area and Safety:**

Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date.
