

On motion of **Mr. Roberts**, seconded by **Ms. Lee-Sheng**, the following resolution was offered:

**RESOLUTION NO. 131528**

A resolution accepting the lowest responsible bid of **Boh Bros. Construction Co., LLC** under Bid Proposal No. 50-00122289 for a two (2) year contract for bridge repair and maintenance for the Jefferson Parish Department of Public Works – Streets at the bid tabulation price of \$4,062,270.00. Maximum expenditures for this contract shall not exceed \$600,000.00 for the two (2) years, by a factor of not more than 10% without amendment to the contract authorized by resolution of the Council. (Parishwide)

**WHEREAS**, bids were received on May 8, 2018; and

**WHEREAS**, the lowest responsible bid was received by Boh Bros. Construction Co., LLC in the amount of \$4,062,270.00; and

**WHEREAS**, expenditures to date have totaled \$42,029.75 for the current contract with Boh Bros. Construction Co., LLC, for the period from June 22, 2016 to May 21, 2018; and

**WHEREAS**, the current contract shall expire on June 21, 2018; and

**WHEREAS**, maximum expenditures shall not exceed \$600,000.00 for the two (2) years, for bridge repair and maintenance.

**NOW, THEREFORE, BE IT RESOLVED** by the Jefferson Parish Council of Jefferson Parish, Louisiana, acting as governing authority of said Parish:

**SECTION 1.** That the lowest responsible bid of Boh Bros. Construction Co., LLC under Bid Proposal No. 50-00122289 for a two (2) year contract for bridge repair and maintenance services for the Jefferson Parish Department of Public Works – Streets, at the bid tabulation price of \$4,062,270.00, be and is hereby accepted.

**SECTION 2.** That costs related to the above are to be charged to Account No. 22200-3000-7344.1 of the Department of Public Works - Streets.

**SECTION 3.** That maximum expenditures shall not exceed \$600,000.00 for the two (2) year(s), by a factor of not more than 10% without amendment to the contract authorized by resolution of the Council.

**SECTION 4.** That the Council Chairperson or, in their absence, the Vice-Chairperson be and is hereby authorized to execute any and all documents necessary to give full force and effect to this resolution.
