Specifications for Model Year 2021 Light Vehicles For Jefferson Parish Department of Fleet Management

Louisiana State Dealer's License:

In accordance with LARS 32:1254 et seq and LARS 38:2212.8, a Louisiana State Dealers License is required. All bidders must provide a copy of their Louisiana Dealer's License with their bid submission. Failure to submit this copy shall result in bid rejection.

SURETY BID BOND:

BID BOND:

A bid bond in the amount of five (5) % of the bid is due with the bid submission. Vendor must submit an electronic bid bond through the respective online clearinghouse bond management system as indicated in the electronic bid solicitation on Central Auction House. Order Placement and Delivery of New Vehicles:

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law.
