All bids submitted are subject to these instructions and general conditions and any special conditions and specifications contained herein, all of which are made part of this bid proposal reference. By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well as in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647. In the event there is a difference in unit prices and totals, the unit prices shall prevail.

The order must not be filled at a higher price than quoted. JEFFERSON PARISH requires all products to be new (current) and all work must be performed according to standard practices for the project. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.

Table corners will withstand a drop squarely on edge/corners from a height of 24 inch at any temperature without splitting apart, cracking, or creating sharp corners. Tables will not emit toxic fumes, gases or smoke in high temperatures related to a fire (passes California Fire Code 133). Alulite products have a Lifetime Guarantee for as long as you own them!

Folding Legs

Alulite legs are aluminum and welded together for strength, then attached to the table with zinc-plated bolts and nuts.

Black powder coat is applied for finishing.

Durable air-craft aluminum will not warp or crack, no matter the event.

Created from aluminum that is 20 percent lighter than "lightweight" plastic tables.
