PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
