- A. Carefully review all components of this RFB. Include with your Bids all required forms, completed and signed as necessary. Bids shall be submitted as either a hard or electronic copy. Bids may be submitted as a hard copy either: 1) via hand delivery to Owner at 16829 East Main Street, Cut Off, LA 70345 or: 2) via mail to "Greater Lafourche Port Commission, Attention: Mrs. April Danos, 16829 East Main Street, Cut Off, LA 70345." Each Proposer(s) shall submit only one (1) original and two (2) copies of their Bids, sealed in an opaque envelope, with the following information legibly written or typed on the face of the envelope as depicted below:
  1. Name and address of Bidder
  2. Name and address of Owner, Attention: Mrs. April Danos
  3. "Proposal for Project – CCTV Gaps Phase IV Slip B Cameras and Equipment"
