Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Section 1.0 Site Visits:

All prospective bidders can schedule a site visit through Mike Fonseca with the Department of General Services between the hours of 8:00 a.m. to 3:00 p.m. Monday through Friday. Mr. Fonseca can be reached at (504)736-6036

Section 2.0 – Scope:

We extend this bid to supply all labor, materials, equipment, and all essential items needed to refurbish the exterior building sign located at Bridge City Senior Center, 1601 Bridge City Avenue, Bridge City, LA 70094.

Section 3.0 –License Requirements:

The following Louisiana State license shall be required for this project:

- Commercial Contractor
- Louisiana State Specialty License in signs, scoreboards, displays, billboards (electrical & non-electrical)

Section 4.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are informational only.

Section 5.0 – Bid Specifications:

- All materials shall be bidder supplied new.
- All materials shall be as specified or owner reviewed and approved equal.
- Materials shall be installed as per all manufacturer recommendations and guidelines.
- Owner shall approve sign design prior to any work commencing.
- All work shall be in accordance with the manufacturer's installation instructions.

Section 5.1 - Sign Design:

- Overall size of the two (2) sign panels shall be approximately 4'0" high by 10'2" wide.
- Owner will supply artwork and layout for sign design, wording, font, color, etc. See attachment A
- Sign faces shall be installed level and plumb.
- Image shall be printed on front and rear face of sign.
- Fonts shall be depicted on drawings for layout approval by owner.
- Laminate covering shall be exterior UV resistant.
- Laminate shall cover the entire back of all aluminum surfaces and used for laminating the face and back of the acrylic portion of the signs.
- All hardware shall be stainless steel.
- Signs base plate shall be 0.063" environmental enamel coated aluminum, precision cut, free of jagged or rough edges.
- Top surface plate to be 0.063" environmental enamel coated aluminum, precision cut, and free of jagged edges and debris.
- All images shall be printed using opaque high-performance exterior vinyl film with permanent adhesive.
- All images digitally printed using UV resistant permanent ink.
- All printed images shall have clean sharp edges.
- Repair scratches and other damage which might have occurred during installation.
- Replace any materials with damages that are visible by the naked eye from a distance of 10 feet or greater.
- Remove and properly dispose all temporary coverings, protectants, and debris from the work site.
- Prior to acceptance of project, the newly installed signs shall be cleaned as per manufacturer guidelines.
- The left and right curved end caps shall be cleaned with pressure/chemical washer.
- Prepped end caps shall be wrapped with 3M Metallic Gold 1080 wrap film series 3.5 mil long-term cast film

Section 6.0 - Hours of Work:

The work that is to be performed shall be scheduled during normal working hours Monday thru Friday 8:30 a.m. to 3:30 p.m.

The successful bidder may choose to work before or after normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish.

Section 7.0 – Cleaning Area and Safety:

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 – Existing Structure

Should any cutting, patching, alteration, addition, or repairs to existing structure, wall, floor, ceiling, or part of building be required of this project, the successful bidder shall restore the alteration to its original condition, with the same type materials, finish, and workmanship.

Section 9.0 – Warranty:

All workmanship shall have a minimum of one (1) year labor warranty. Five (5) year commercial warranty on the 3M products. 




