The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. Bidders are required to complete, sign and return the bid form and/or complete and return the associated line item pricing forms as indicated. The price quoted for work shall be stated in figures. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. **Wager Odor Control Media
Specifications

This specification defines the requirements for dry scrubbing media pallets for use in Wager 2050i450 vent scrubber valve units already in place at the following sewer lift stations: Karen & Canton (F4-1); Four Bayous (D6-5); West Metairie & Transcontinental (E5-4); Woodmere Plant (N-13-8; Barataria & College (K-14-5); Barataria & Cousins (L12-3).

Each media pallet shall contain 450 lbs. of dry-scrubbing media in pellet form, that is engineered for the removal of H₂S gas. The media is contained in (9) corrugated plastic containers that are 11.6 inch X 18 inch in size. Each canister contains 50 LBS of odor scrubbing media.

The configuration shall be arranged so that the contaminated air shall flow from the bottom flange and be forced upward through the media bed and discharged through the ventilated openings of the valve unit.

Only non-toxic, landfill disposable media will be accepted.

Activated alumina or carbon media will not be accepted.

A. Media Specification

1. Moisture content: 35% Max
2. Crush Strength: 35% - 70% Max
3. Abrasion: 4.5% Max
4. Pellet Diameter: 1/16" (1.5mm-6.5mm)

B. The media specified must be fit into the Wager odor control valve units already in place. No equals will be accepted.

C. Only UL certified media will be accepted in Wager's vend scrubber.
