**SUPPLY AND INSTALL ELASTOMERIC SILICONE ROOF COATING SYSTEM AT
THE JEFFERSON PARISH THOMAS DONELON BUILDING**

Section 1.0 - Site Visits:

All prospective bidders can schedule a site visit through Tim Hoskins with the Department of General Services between 8:00 a.m. to 3:00 p.m., Monday Thru Friday. Mr. Hoskins can be reached at 504-364-2675.

Section 2.0 – Scope:

We extend this proposal to cover the installation of a pure elastomeric silicone coating over the existing roofs of the Thomas Donelon Building located at 200 Derbigny Street, Gretna, LA 70053. All preparation and installation shall follow manufacturer guidelines and instructions. See attachment “A” for building location and areas of the top to be coated.

Line item 1:

Base bid:

All work is described in these specifications, excluding sections nine (9) and ten (10) for ancillary work.

Line Item 2:

Ancillary Work:

Provide a cost per square foot to remove, repair, and replace water-damaged roofing materials described in Section 10.0 of these specifications. This identified cost will not be part of the base bid and will not be used to determine the low bidder. This line item will only be used if needed.

Section 3.0 –License Requirements:

A Louisiana State Contractor’s License issued by the Louisiana State Licensing Board for Contractors shall be required in all of the following classifications:

- Commercial Contractor

And/or

- A specialty license in roofing and Sheet Metal Siding

A Louisiana State Contractor’s License will be required for this bid in accordance with LSA R.S. 37-2150 et. seq. such license(s) number(s) will be shown on the outside of the bid electronic envelope. Failure to comply will cause the bid to be rejected.

Section 4.0 – Bonds

Bid Bond

A bid bond will be required with bid submission in the amount of 5% of the total bid. Vendors must submit an electronic bid bond through the respective online clearinghouse bond management system(s) as indicated in the electronic bid solicitation on Central Auction House. Vendor shall indicate the electronic bid bond number in the location specified on the electronic bid envelope. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.

Performance Bond:

A Performance Bond in the amount of 100% of the total contract price will be required. The performance bond shall be produced upon contract execution.

Section 5.0 – Quantities/Inspection:

Bidders must inspect the site and perform their own measurements to determine the proper quantity of labor, materials, and equipment required to complete this project.

Section 6.0 – Submittals:

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided with bid submission. Failure to provide the requested information with your bid will result in the bid being deemed non-responsive.

- Manufacturer's catalog data
- Detail sheets
- Specifications of product
- Warranty information

Section 7.0 – Bid Specifications:

- All materials shall be as specified new.
- All materials shall be applied as per all manufacturer recommendations and guidelines. See attachment "A" for building location and areas of the roof to be coated.
- A field manager certified by the manufacturer of the product being applied along with the owner shall inspect the site and verify the work daily.

7.1 Before work beginning:

- Successful bidder and an owner's representative shall inspect, document, and take photos of all existing building and roof conditions.
- Two weeks before installing new materials, an adhesion test shall be performed, and a typed written report shall be provided to the Department of General Services within seven days of completion of the test.

7.2 Preparation of Roof:

- Clean existing roof with Unisil cleaning concentrate agent and de-greaser.
- Prime existing roof with Unisil two-component, water-based primer.
- Seal all roof penetrations, splits, edge metal, and drains with Roof Mate Butter Grade water-based, high solid elastomeric sealant.
- Seal all roof penetrations, splits, edge metal, and drains with Roof Mate stitch-bonded, 100% polyester Fabric.

7.3 Application of Coating:

- Apply Unisil Roof Coating high volume solid, pure elastomeric silicone coating to the entire roof.
- Roof coating shall be applied per manufacturer recommendations and guidelines to successfully achieve the twenty-year warranty required for this project.
- Contrasting colors shall be used for each coat to ensure positive, uniform coverage. This also applies to the flashing membrane.
- Product manufacturer suggested drying time shall be allowed between coats.

Section 8.0 Product Description:

Section 9.0 - Inferred Moisture Survey:

- Thirty Days before the start of the project, an infrared moisture survey shall be performed on the entire roof surface by a certified representative of the roof coating manufacturer.
- All areas of the roof shown to be wet shall be marked with yellow spray paint.
- On the same day the inferred scan is complete, all wet areas shall be verified using a pin-type moisture meter.
- For an accurate reading, the pins of the moisture meter shall be inserted through the granulated cap sheet and into the existing roof insulation.
- Five (5) days after the infrared moisture survey scan concludes, a standard drawing showing all wet areas and a typed written report listing all information noted during the survey shall be provided to the owner.

Section 10.0 – Remove, Repair, and Replace Water Damaged Roofing Material:

- This work will only be used on an as-needed basis predicated on the results of the moisture test described in Section 9.0.
- Remove water damaged area down to metal roof deck.
- Install new bidder-supplied insulation to match existing insulation.
- Thickness of new insulation shall match existing insulation.
- Fasten insulation with mechanical fasteners and deck mate screws.
- Apply a base sheet of SBS granulated membrane.
- Prime with a top finish coat to match the existing roof membrane.
- Apply a cap sheet to match the existing roof membrane.

Section 11.0 - Hours of Work:

Work that shall not affect the normal operation of this facility can be scheduled during normal working hours Monday thru Friday, 7:00 a.m. – 4:00 p.m. Any work that may affect the facility's normal operation must be scheduled after normal working hours or on weekends.

Section 12.0 – Safety Precautions:

Safety precautions must be exercised to safeguard the welfare and safety of the building employees and public while any work is being performed.

Section 13.0 – Existing Structure

If the successful bidder should damage or destroy any part of a building, etc., the successful bidder shall be required to replace and restore said item to its original condition, with the same type of material, finish, and workmanship at no additional cost to the owner.

Section 14.0 – Material and Workmanship Warranty:

All materials and workmanship shall have a twenty (20) year warranty in writing from the manufacturer.

A copy of all warranties shall be provided to the owner at the completion of the project.
All warranties shall commence at the completion of the project.

Section 15.0 – Safety Data Sheet (SDS):

The bidder shall notify the Jefferson Parish Department of General Services contact person of any hazardous substances brought to and used at the workplace. The bidder shall provide SDS as per this requirement to the Jefferson Parish Department of General Services Director.

Section 16.0 – Liquidated Damages:

Commencing on the thirty-first (31) day, liquidated damages in the amount of \$300.00/Day will be assessed until work is completed.

Section 17.0 – Start of Work Conference and Notice to Proceed:

A "Start of Work Conference" shall be held between the successful bidder and the owner before any work commencing.

No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work from the Department of General Services.

Contributions made or costs reasonably anticipated for bona fide fringe benefits under section 1(b)(2) of the Davis-Bacon Act on behalf of laborers or mechanics are considered wages paid to such laborers or mechanics, subject to the provisions of paragraph (a)(1)(iv) of this section; also, regular contributions made or costs incurred for more than a weekly period (but not less often than quarterly) under plans, funds, or programs which cover the particular weekly period, are deemed to be constructively made or incurred during such weekly period. forth the time spent in each classification in which work is performed. The wage determination (including any additional classification and wage rates conformed under paragraph (a)(1)(ii) of this section) and the Davis-Bacon poster (WH-1321) shall be posted at all times by the contractor and its subcontractors at the site of the work in a prominent and accessible place where it can be easily seen by the workers.

(ii)

(A) The contracting officer shall require that any class of laborers or mechanics, including helpers, which is not listed in the wage determination and which is to be employed under the contract shall be classified in conformance with the wage determination. The contracting officer shall approve an additional classification and wage rate and fringe benefits therefore only when the following criteria have been met:

(1) The work to be performed by the classification requested is not performed by a classification in the wage determination; and

(2) The classification is utilized in the area by the construction industry; and

RIGHTS TO INVENTIONS MADE UNDER A CONTRACT OR AGREEMENT

(1) *Invention* means any invention or discovery which is or may be patentable or otherwise protectable under Title 35 of the United States Code, or any novel variety of plant which is or may be protected under the Plant Variety Protection Act (7 U.S.C. 2321 *et seq.*).

(2) *Subject invention* means any invention of the *contractor* conceived or first actually reduced to practice in the performance of work under this *contract*, provided that in the case of a variety of plant, the date of determination (as defined in section 41(d) of the Plant Variety Protection Act, 7 U.S.C. 2401(d)) must also occur during the period of *contract* performance.
