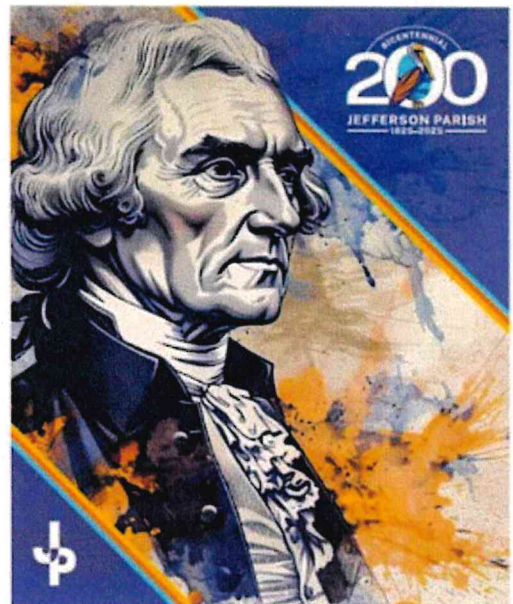

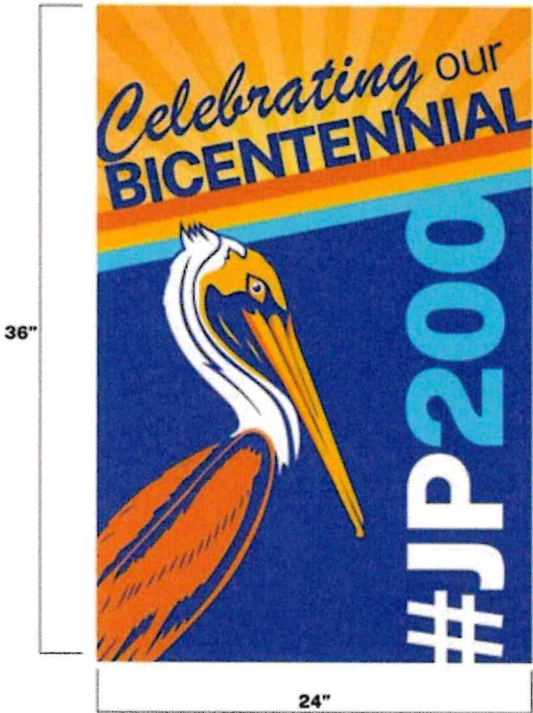

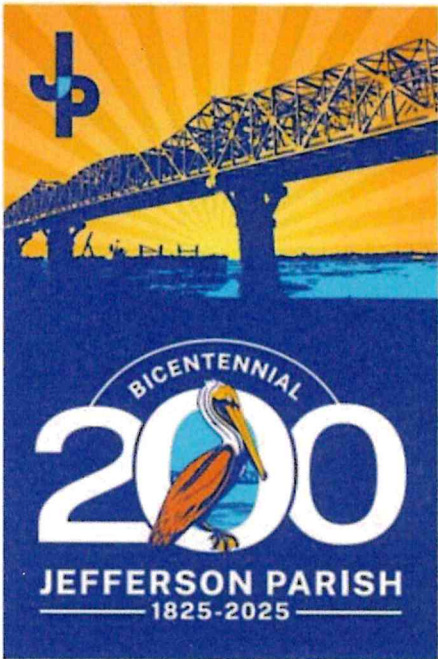

The way that you requested can be done but is much more costly and labor intensive.

So my question is, do we have to quote as requested or can I use double sided banner material that is not hemmed on left and right?
