

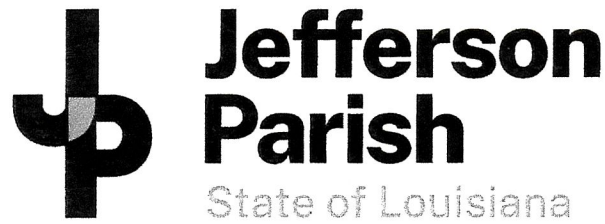

By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 136353 and/or Resolution No. 141125 as amended. A copy of these resolutions may be obtained from the Office of the Parish Clerk, Suite 6700, Jefferson Parish General Government Building, 200 Derbigny Street, Gretna, LA 70053. All vendors submitting bids should register as a Jefferson Parish vendor if not already yet registered. Registration forms may be downloaded from <http://purchasing.jeffparish.net> and by clicking on Vendor Information. Current W-9 forms with respective Tax Identification numbers and vendor applications may be submitted at any time; however, if your company is not registered and/or a current W-9 form is not on file, vendor registration is mandatory. Vendors may experience a delay in payment if your company is not a registered vendor with Jefferson Parish.

Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail. Quotations shall be based on F.O.B. Delivered, anywhere within the Parish as designated by the Purchasing Department. JEFFERSON PARISH WILL ACCEPT ONE BID ONLY FROM EACH VENDOR. Items bid must meet specifications. JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. Bidders are required to complete, sign and return the bid form and/or complete and return the associated line item pricing forms as indicated. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit prices shall prevail.

JEFFERSON PARISH reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of JEFFERSON PARISH. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)

JEFFERSON PARISH reserves the right to cancel all or any part of an order if not shipped promptly. No charges will be allowed for parking or cartage unless specified in the quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel at any time and for any reason by issuing a THIRTY (30) day written notice to the contractor.

JEFFERSON PARISH requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year warranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alteration from the specifications must be indicated on the bid form for each item and upon request, product data for same must be submitted by the time specified by the Purchasing Department.

If this bid requires a pre-bid conference (see Additional Requirements section), bidders are advised that such conference will be held to allow bidders the opportunity to identify any discrepancies in the bid specifications and seek further clarification regarding instructions. The Purchasing Department will issue a written response to bidders' questions in the form of an Addendum.

5. It is the bidder's responsibility to visit the job site and evaluate the job before submitting a bid.
6. Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Flammable material must be removed from the job site daily because storage will not be permitted on the premises. Precaution must be exercised at all times to safeguard the welfare of JEFFERSON PARISH and the general public.
7. **PUBLIC WORKS BIDS:** All awards for public works in excess of \$5,000.00 will be reduced to a formal contract which shall be recorded at the contractor's expense with the Clerk of Court and Ex-Officio Recorder of Mortgages for the Parish of Jefferson. A price list of recordation costs may be obtained from the Clerk of Court and Ex-Officio Recorder of Mortgages for the Parish of Jefferson. All awards in excess of \$25,000.00 will require both a performance and a payment bond. Unless otherwise stated in the bid specifications, the performance bond requirements shall be 100% of the contract price. Unless otherwise state in the bid specifications, the payment bond requirements shall be 100% of the contract price. Both bonds shall be supplied at the signing of the contract.
8. **NON-PUBLIC WORKS BIDS:** A performance bond will be required for this bid. The amount of the bond will be 100% of the contract price unless otherwise indicated in the specifications. The performance bond shall be supplied at the signing of the contract.



BULK MULCH AND PINE NEEDLES

Section 1.0 – Pre-Bid Conference:

There will be no pre-bid conference for this bid.

Section 2.0 – Scope:

This shall be a one (1) year contract to provide mulch to the Jefferson Parish Parkways Department. All unit pricing shall include material, freight, taxes and necessary essentials to provide mulch on an as-needed basis. There is no minimum, or maximum, quantity of mulch to be provided with this contract.

Section 3.0 – Delivery:

The vendor shall be responsible for delivery of requested mulch to locations determined by the Jefferson Parish Parkways Department. The vendor shall determine the best methods, equipment and incidentals for successful delivery of requested material. Unit pricing shall include delivery to any location within Jefferson Parish, excluding Grand Isle.

Whenever possible, bulk mulch shall be ordered in 88 cubic yard increments.

The vendor shall be responsible for any site damage caused by his equipment when delivering mulch. This shall include, but not be limited to, ruts, broken pavement and property damage.

Section 4.0 – Mulch Specifications:

All mulch shall be free of any debris, trash and dissimilar material. When delivered, bulk mulch shall include a haul ticket stating the quantity of mulch included in the delivery. All bag mulch shall be delivered in seal packaging clearly stating the type of product contained in the bag.

Bulk Pine Mulch:

Bulk pine shall consist of shredded pine wood and bark. Processed final product should yield individual wood pieces 2" long or shorter. Mulch color shall include red and brown tones.

Bulk Hardwood Mulch:

Bulk hardwood mulch shall consist of shredded hardwood material such as oak, ash, elm, hickory and maple. The processed final product should yield individual wood pieces 2" long or shorter and may consist of a variety of hardwood species. Mulch color shall be dark brown.

Longleaf Pine Needles (Bale):

Longleaf baled pine needles shall arrive in tied (compressed) bundles. Each bale shall be a minimum of 4 cubic feet in size. Needles shall average approximately 14" in length. Bales shall be fresh and have a bright red color. All bales in a single delivery shall be uniform in color.

Grade A Crushed Pine Needles (Bag):

Grade A crushed pine mulch shall arrive in sealed bags. Each bag shall contain a minimum of 2 cubic feet of mulch. Needles shall average approximately 4" in length. Bag mulch shall be bright red in color. All bag mulch in a single delivery shall be uniform in color.

Softscape Sienna Mulch (Bag):

Softscape Sienna mulch, manufactured by Mulch Manufacturing, Inc., shall arrive in the original manufacturer's packaging. Each bag shall contain a minimum of 2 cubic feet of mulch. Bag mulch shall be bright red (sienna) in color. As-equal products shall be submitted to the Jefferson Parish Parkways Department for approval prior to ordering.

Section 5.0 – Purchase Order:

The vendor must receive a Purchase Order from Jefferson Parish prior to ordering/delivering any mulch.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 113646 or No. 113647, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected.
