By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law, as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647. In the event there is a difference in unit prices and totals, the unit prices shall prevail.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(l), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. DeNora Meter Panels

- A. The single meter panel shall be wall mounted and provided with a chlorine gas flowmeter with dual scale (English/metric) indication. The flowmeter shall have a feed rate capacity up to 500 PPD/10 kg/h.
- B. The meter panel shall contain a manually adjusted rate valve. The rate valve and seat shall be solid silver. The gas flowmeter shall have dual scale (English/metric) and be sized for an operating maximum capacity of 500 PPD/10 kg/h.
- C. The remote meter panel shall be constructed of molded plastic, suitable for wet or dry gas service.
- D. The vacuum inlet and outlet shall be 5/8 inch.
- E. The following meter panel spare parts shall be provided:
 - 1. One (1) set rate valve O-rings.
 - 2. One (1) set meter gaskets.
- F. The meter panel shall be DeNora Model RM500C1

GAS FEEDERS / VACUUM REGULATORS WITH RATE VALVE

- A. The vacuum regulator shall feed gas under vacuum from the source to the point of application up to a feed rate of 500 PPD of chlorine gas.
- B. The vacuum regulator shall mount directly on the ton container gas valve by means of a yoke assembly and shall be provided with a gas valve direction indicator, integrated gas flow meter and solid silver rate valve. The gas flow meter shall have dual scale English and be sized for an operating maximum capacity of 500 PPD.
- C. The vacuum regulator shall be constructed of molded plastic, suitable for wet or dry gas service and all springs shall be of tantalum alloy. The corrosion-resistant yoke assembly shall have a fusion-bonded epoxy coating and shall be fitted with a field replaceable silver inlet valve and filter assembly.
- D. Vacuum shall be controlled by a spring-opposed double diaphragm in the vacuum regulator. Pressure shall be prevented from building in the system by means of a spring-loaded, diaphragm actuated pressure relief valve located in the vacuum regulator. Each regulator shall be equipped with a gravity-actuated loss-of-gas indicator. An integrated switch shall be provided to indicate loss of gas.
- E. The vacuum inlet shall be 5/8 inch.
- F. The vacuum regulator shall be fitted with a gas filter having an area of at least 4 square inches and a pore size of 90 microns. It shall include an integral liquid trap and an electric heater, which shall prevent any liquid, which may enter the trap, from reaching the regulator. The heater shall operate on 120 VAC, 60 Hz power and shall be complete with a 10-foot line cord.
- G. The vacuum regulator shall be DeNora Model NXT3000.
- H. Where applicable, all parts, associated with rebuilding DeNora chlorine vacuum regulators, must be OEM and be in original packaging. No substitutions will be accepted.
