Two (2) year contract for the supply of base course crushed concrete for the Jefferson Parish Department of Public Works - Streets and all Jefferson Parish agencies and municipalities.

Aggregates shall comply with section '1003 Aggregates' of Louisiana Standard Specifications for Roads and Bridges 2006 edition and any further revisions.

Base Course Aggregate:

The material shall conform to the following gradation:

Specifications shall follow section 301-base course of Louisiana Standard Specifications for Roads and Bridges and referenced sections, under "stone" in addition, the material shall be calcitic or dolimitic with calcium carbonate not less than 85 percent and the silica content (impurities) not to exceed 5 percent.

Stockpiles of crushed concrete shall be uniform and free of soils, reinforcing steel, debris, excessive amount of asphaltic materials and other foreign matter. Material sampling shall be in accordance with the requirements for stone by the Louisiana Department of Transportation and Development, Section 301 of The Materials Sampling Manual Crushed Concrete shall conform to the abrasion and soundness requirements of Subsection 1003.01 of the Standard Specifications for Roads and Bridges. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. 
