The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:

Bidder acknowledges that Bidder recovered the cost of any required insurance in the contract price as required by La.R.S. 9:2780.1 and that Bidder recovered any such cost for the purposes of insuring an obligation to indemnify Jefferson Parish, defend Jefferson Parish, or hold Jefferson Parish harmless and that Bidder's indemnity liability is limited to the amount of the proceeds that are payable under the insurance policy or policies that Bidder has obtained.

Electronic Procurement: Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. Central Bidding can be accessed by visiting either www.centralbidding.com or www.jeffparishbids.net. All bidders will be required to register with Central Bidding. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.

Such liquidated damages shall be computed with respect to each individual laborer or mechanic, including watchmen and guards, employed in violation of the clause set forth in subparagraph (1) of this paragraph, in the sum of \$10 for each calendar day on which such individual was required or permitted to work in excess of the standard workweek of 40 hours without payment of the overtime wages required by the clause set forth in subparagraph (1) of this paragraph.

What is Premarket Notification 510(k)?

A 510(k) is a premarket submission made to FDA to demonstrate that the device to be marketed is as safe and effective, that is, substantially equivalent, to a legally marketed device (section 513(i)(1)(A) FD&C Act)

Who is Required to Submit a 510(k)?

- The following four categories of parties must submit a 510(k) to the FDA:
 - Finished device manufacturers must submit a 510(k) if they manufacture a device according to their own specifications and market it in the U.S. However, manufacturers of device components are not required to submit a 510(k) unless such components are promoted for sale to an end user as replacement parts.
 - Specification developers introduce a device to the U.S. market;
 - A specification developer develops the specifications for a finished device, but has the device manufactured under contract by another firm or entity. The specification developer submits the 510(k), not the contract manufacturer.
 - Repackagers or relabelers may be required to submit a 510(k) if they significantly change the labeling or otherwise affect any condition of the device.
 - Foreign manufacturers/exporters or U.S. representatives of foreign manufacturers/exporters introducing a device to the U.S. market.

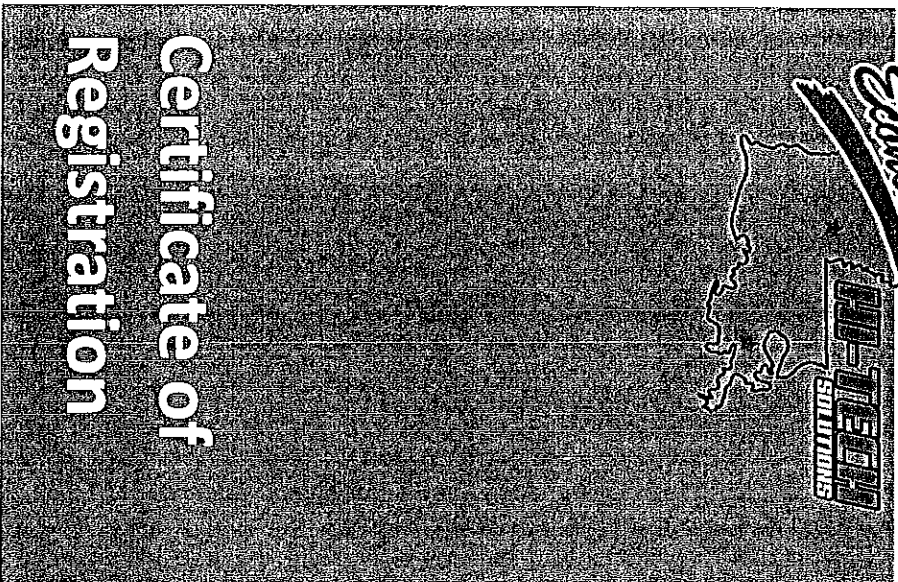
When a 510(k) is Not Required

- You sell unfinished devices to another firm for further processing or sell components to be used in the assembling of devices by other firms.
- Your device is not being marketed or commercially distributed, include: develop, evaluate, or test a device. This includes clinical evaluation.
- You distribute another firm's domestically manufactured device. You may place a label on the device, "Distributed by ABC Firm," or "Manufactured for ABC Firm," (21 CFR 801.2) and sell it to end users without submission of a 510(k).
- In most cases, if you are a repackager or relabeler and the existing labeling or condition of the device is not significantly changed without submission of a 510(k).
- The device is made outside the U.S. and you are an importer of the foreign made medical device. A 510(k) is not required if a 510(k) has been submitted by the foreign manufacturer and received marketing clearance.
- Certain Class I or II devices can be marketed for the first time without having to submit a 510(k).
