Gentlemen:

CONSTRUCTION CONTRACT CLAUSES / A.I.P. PROJECTS

SC-2.1 GENERAL

Federal laws and regulations require that recipients of federal assistance (Sponsors) include specific contract provisions in certain contracts, requests for proposals, or invitations to bid. For the purpose of this Special Condition, the words "Sponsor", "Owner", and "Airport" shall be considered interchangeable and interpreted to refer to the Owner.

Certain provisions must be included in all sponsor contracts, regardless of *whether or not* the contracts are federally-funded. This requirement was established when a sponsor accepted the Airport Improvement Program (AIP) grant assurances.

To maintain eligibility of their procurement actions, the Sponsor has incorporated applicable contract provisions in this contract. For purposes of determining requirements for contract provisions, the term *contract* shall also include all subcontracts.

The Bidder shall incorporate the requirements of this Special Condition by reference in all sub-contracts, purchase orders, rental agreements, and other agreements for supplies or services provided under the prime contract.

The Bidder shall also be responsible for verifying compliance with these Special Conditions by his own organization, sub-contractors, lower tier sub-contractors, suppliers, and service providers.

SC-2.2 ACCESS TO RECORDS AND REPORTS

The Contractor must maintain an acceptable cost accounting system. The Contractor agrees to provide the sponsor, the Federal Aviation Administration, and the Comptroller General of the United States or any of their duly authorized representatives, access to any books, documents, papers, and records of the contractor which are directly pertinent to the specific contract for the purpose of making audit, examination, excerpts and transcriptions. The Contractor agrees to maintain all books, records and reports required under this contract for a period of not less than three years after final payment is made and all pending matters are closed

SC-2.3 AFFIRMITIVE ACTION REQUIREMENT

**NOTICE OF REQUIREMENT FOR AFFIRMATIVE ACTION to
ENSURE EQUAL EMPLOYMENT OPPORTUNITY**

1. The Offeror's or Bidder's attention is called to the "Equal Opportunity Clause" and the "Standard Federal Equal Employment Opportunity Construction Contract Specifications" set forth herein.

2. The goals and timetables for minority and female participation, expressed in percentage terms for the contractor's aggregate workforce in each trade on all construction work in the covered area, are as follows:

Goals for minority participation for each trade: 26.5%

Goals for female participation in each trade: 6.9%

These goals are applicable to all of the contractor's construction work (whether or not it is Federal or federally-assisted) performed in the covered area. If the contractor performs construction work in a

geographical area located outside of the covered area, it shall apply the goals established for such geographical area where the work is actually performed. With regard to this second area, the contractor also is subject to the goals for both its federally involved and non-federally involved construction.
