The Contractor shall also be responsible for delivery of signs to the Traffic Engineering Division when the project is completed. Prior to installation, location of the signs shall be approved by the Jefferson Parish Traffic Engineering Division (504-736-6500).

3. Specifications: TECHNICAL SPECIFICATION, SECTION 203 "EXCAVATION AND EMBANKMENT" Under 203.03 SUBMITTAL **ADD** the following below the second paragraph:

Prior to commencing any work, the Contractor shall submit to the Engineer for review, his excavation and dewatering plans for all excavations. Such review is to demonstrate that the Contractor has fulfilled the requirements of this section. Any subsequent deviation from the reviewed plan or amendments thereto must have the prior approval of the Contractor's engineer with a subsequent review by the Engineer.

The excavation and dewatering plans shall be stamped and certified by a professional engineer(s) registered in the State of Louisiana. Said engineer(s) shall have demonstrated experience in groundwater hydraulics and steel sheet pile design, respectively, and as applicable.

The engineer(s) designing the excavation and dewatering plans shall have professional liability insurance of not less than \$500,000.00. Proof of insurance shall be submitted with the plans in the name of the engineer performing such designs. The submitted insurance certificate shall name Jefferson Parish and the designer of record as additional insured.

Should the design of the Contractor's sheeting and dewatering plans not be performed by the same engineer, such engineers shall coordinate their designs. Acknowledgement of the design coordination must be submitted with their design by both engineers.

Any engineer(s) utilized for the design of the dewatering plan and the design shall conform to all of the above requirements.

The methods and operation outlined in the excavation plan shall comply with all local codes and laws, and authorities having jurisdiction.

The Contractor shall submit his proposed method of construction which shall include the methods for excavating, protection of existing utilities, dewatering and pressure relief, sheeting, shoring and bracing, and backfilling which he plans on using to perform the work included in the contract documents. The plan shall include but not be limited to:

- (a) Type of major excavation equipment and type of equipment and method of driving sheeting.
- (b) Sheeting, shoring and bracing plan
- (c) Dewatering and pressure relief plan
- (d) Hauling equipment, and proposed excavation quantities

- (e) Proposed haul routes of excavation and material supply equipment
- (f) Handling and storage of materials on site
- (g) Provisions for compliance with permits and regulations

There shall be no direct payment for preparation of an excavation plan and all costs associated with the installation and removal thereof shall be included in the costs associated with the construction of the appropriate item.

QUESTIONS AND CLARIFICATIONS

BIDDER QUESTIONS RECEIVED

- (Q) On sheet 15 you show straps on needed to connect the first 3 boxes on each end.
Question is do the anchor bolts need to be cast into the box or can the boxes come out with sleeves cast in and bolt through the top of the box to hold down these straps??
- (A) Bolts were intended to be field installed; cast in sleeves will be allowed.
- (Q) Sheet 10 of 28 shows the Temporary Detour road on the west end of the project (Ole Miss Dr.), will there be similar modifications/Temporary Detour road required on the east end of the project (Continental St.)? If so, please provide details as shown on sheet 10 for the east end of the project.
- (A) The intersection at Continental St. is sufficient to accommodate detour without pavement modifications.
- (Q) Please check your class II base course plan quantity. If it is only for the new roadway, then it seems like way more than what will be needed. $2 \times 135' \times 30' \times .5' / 27 = 150 \text{cy}$. If the class II base is measured for payment somewhere else on this project, please let me know.
- (A) The Class II base course quantity should be 160 CY. See attachment No. 1 of this addendum, revised Louisiana Uniform Public Work Bid Form.
- (Q) Which pay item should we put the demolition of the 96" RCPA?
- (A) Item 201-01-00100 Clearing and Grubbing and Misc. Demo.
- (Q) Which pay item should we put the cofferdam installation and removal?
- (A) Cofferdam install, and removal is at No Direct Pay; see item No. 4 of this addendum.
- (Q) Which pay item should we put the "select excavated material free of stumps and voids" in? (This is the layer between the sand backfill and the topsoil.)
- (A) All work with select Excavated Material is covered under the Lump Sum price for item No. 203-02-00100 Drainage Excavation; suitable excavated material may be utilized as fill as indicated by Key Point #7 sheet 3 of 28.

- (Q) SP20 and SP21 both talk about deenergizing power lines, but conflict on who is responsible for paying Entergy. Please review and clarify.
- (A) The Owner (Jefferson Parish) will pay Entergy.
- (Q) We don't see any required temp striping for the detour plans; is this correct?
- (A) Temporary striping is required, as outlined on the Traffic Control Plans, Phases I & II, sheets 15 & 16 of the project plans.
- (Q) Also, during the detour, at Ole Miss Street (Plan Sheet 10) notes indicate striping to be put back. Are you requiring the existing stop bars and cross walk striping to be grinded out?
- (A) Contractor shall remove existing striping and replace upon ending detour.
- (Q) Will the contractor be allowed to use crushed concrete for base course and bedding material?
- (A) Yes; provided the crushed stone meets the same gradation requirements as the stone.
- (Q) Will the contractor be allowed to use all 4 sides of the canal bank for storage and parking?
- (A) Yes.
- (Q) Please provide details of the existing bents that need to be removed. How many piles per bent? What is the bent caps dimensions and type of material?

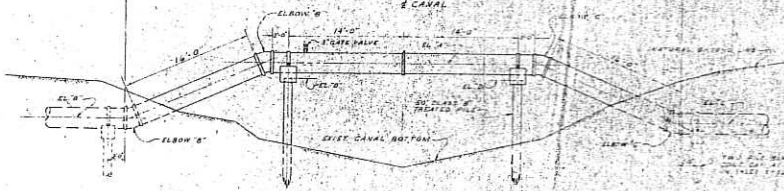

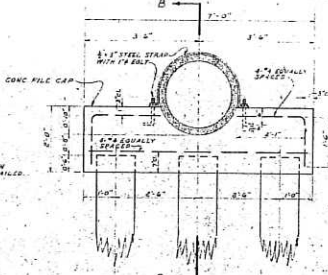
PLAN VIEW OF PIPE CROSSING TYPE "A-1"

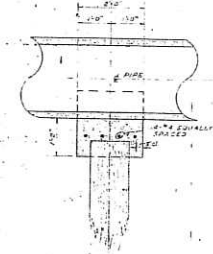
SOUTH ELEVATION OF PIPE CROSSING TYPE "B-1"

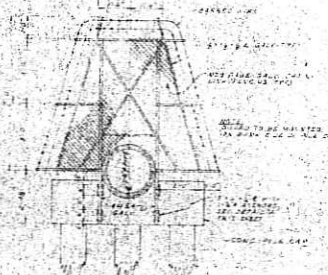
PLAN VIEW OF PIPE CROSSING TYPE "B-1"

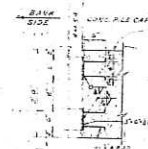

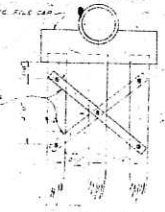

- (A) See attachment No. 2 of Addendum No. 1.
- (Q) What is the canal typical water elevation?
- (A) The normal dry weather canal water level is approximately -11.43' NAVD 88.
- (Q) Can the box culvert be cast in place instead of precast?
- (A) Yes, however no additional contract time will be granted for this work and the cast in place unit shall be designed for HS20-44 Wheel Loading and be certified by an Engineer registered in the state of Louisiana. A full submittal with design calculations will be required for acceptance.
- (Q) An Air Release Valve manhole is shown on sheet 4 of 28 over the required 6" sewer pipe. No detail is provided. Can a separate pay item be added for the work required to install the valve and manhole?
- (A) Air release valve is to be installed in a Jefferson Parish Standard Brick Manhole; see Drainage Standard Details Sheet 1 of 3 sheet 26 of the project plans for manhole details. The brick manhole and the air release valve shall be at No Direct Pay and shall be included under item 702-01-00100.
- (Q) Note 1 and 2 on sheet 2 under Roadways and Sidewalks indicate subbase compacted to 97%. Sheet 3 of 28, key notes indicate subbase compacted to 95%. Please revise.
- (A) 95% Compaction is required.
- (Q) Sheet 7 - the surveyor located a 24" AC water line in the median. Sheet 8 identifies this line as a 16" line. Do we replace the 24" AC with a 16" and have to make tie-ins to the existing 24" AC pipe, or is this a mistake?
- (A) The project plans depict the a 16" waterline based upon Jeff Parish Waterline records, the work is to be bid based upon a 16" waterline. (Survey reflects pipe OD)
- (Q) Notes 7 and 8 on sheet 9 indicate that the gas line and power lines on the south side will have to be relocated and to coordinate work with the utility companies. What about the gas line and power lines on the north side? are those also to be relocated?
- (A) All Entergy electrical lines shall be rerouted by October 19th this rerouting electrical lines and Atmos is rerouting the gas lines. Owner is covering all cost. OHP lines will be relocated out of the parish ROW prior to beginning of construction.



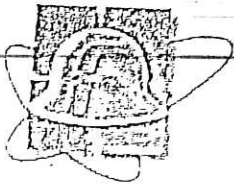
