

On motion of **Ms. Lee-Sheng**, seconded by **Mr. Roberts**, the following resolution was offered:

**RESOLUTION NO. 130211**

A resolution accepting the lowest responsible bid of **Magee Excavation & Development, LLC** received on October 5, 2017, under **Proposal No. 50-120486** in the amount of \$679,000.00 for Canal Street Corridor Improvements - Median Enhancements (between I-10 and Lake Avenue) Public Works Project No. 2013-041-RB. (Council District No. 5)

**WHEREAS**, Jefferson Parish received bids on October 5, 2017, for the construction of Canal Street Corridor Improvements Median Enhancements (between I-10 and Lake Avenue) Public Works Project No. 2013-041-RB; and

**WHEREAS**, Magee Excavation & Development, LLC submitted the lowest responsible bid under Proposal No. 50-120486 in the amount of \$679,000.00; and

**WHEREAS**, the engineer, Linfield, Hunter, and Junius, Inc., has reviewed the bids and has recommended that award of contract be made to Magee Excavation & Development, LLC; and

**WHEREAS**, the project was bid as a base bid and two alternate bids; and

**WHEREAS**, the project is being funded with local funds and those funds are sufficient to construct the scope of work contained in the Base Bid and Alternate Bid No. 1 and Alternate Bid No. 2.

**NOW, THEREFORE, BE IT RESOLVED**, by the Parish Council of Jefferson Parish, Louisiana, acting as governing authority of said Parish:

**SECTION 1.** That the lowest responsible bid (Base Bid plus Alternate Bid No. 1 plus Alternate Bid No. 2) received from Magee Excavation & Development, LLC on October 5, 2017, under Proposal No. 50-120486 in the amount of \$679,000.00 for Canal Street Corridor Improvements - Median Enhancements (between I-10 and Lake Avenue) Public Work Project No. 2013-041-RB is hereby accepted.

**SECTION 2.** That the Chairperson of the Jefferson Parish Council, or in his or her absence the Vice-Chairperson, be and they are hereby authorized, empowered and directed to sign and execute a contract with Magee Excavation & Development, LLC, which contract shall include the bid proposal, plans and specifications for said project.

**SECTION 3.** That all work related to the construction of Canal Street Corridor Improvements - Median Enhancements (between I-10 and Lake Avenue) shall be charged to Account No. 45230-4039-7454 (52356.047).

**SECTION 4.** That the term of this contract shall commence on the date indicated on the Notice To Proceed.
