Section 2.0 - Scope:

We extend this bid to cover all labor, materials, and necessary essentials to repair tape, float, texture, prime, and paint drywall walls at the Jefferson Parish 2nd Parish Court at 100 Huey P. Long Ave., Gretna, La 70053.

Section 3.0 -License Requirements:

A copy of the front and if applicable the back of all licenses and endorsements listed below shall be submitted with bid submission. Failure to submit this information with bid submission will deem the bid non-responsive.

Section 3.1- License required for this bid issued by the Louisiana State Licensing Board for Contractors:

- Commercial License
- Building Construction, and/ or Painting, Coating and Blasting.

Section 4.0 - Quantities/Inspection:

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project. All measurements given in these specifications are for informational purposes only.

Section 5.0 - Bid Specifications:

- Labor and materials to repair, tape, float, texture, prime, and paint approximately 3,600 sq foot room with 10ft height walls.

- All work is to be performed on the 1st floor of the 2nd Parish Court Clerk Of Court office at 100 Huey P. Long Ave., Gretna, La 70053.
- All materials shall be bidder supplied new.
- All materials shall be as specified or owner reviewed and approved equal.
- All materials shall be installed as per manufacturer recommendations and guidelines.
- Prime and paint walls to match existing walls.
- Apply two (2) coats of paint to match color of existing walls.

Section 6.0 - Hours of Work:

The work that is to be performed shall be scheduled during normal working hours Monday thru Friday 7:30 a.m. thru 4:30 p.m. The successful bidder may choose to work before or after normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish. All work shall be scheduled seventy two (72) hours in advance and shall be completed, work area cleaned, and the area ready to open for the next business day.

Section 7.0- Cleaning Area and Safety:

Job site must be clean and free of all construction debris and related litter daily and upon completion of the job. Passageways must be kept clean and free of material, equipment, and debris at all times. Flammable material must be removed from the job site daily, because storage will not be permitted on the premises. Precautions must be exercised at all times to safeguard the welfare and safety of the general public, employees of Jefferson Parish, and other Parish officials.

Section 8.0 - Existing Structure:

Should any damage be caused by this work the successful bidder shall restore the damage to its original condition, with the same type materials, finish, and workmanship.

Section 9.0 - Warranty:

All workmanship and materials must have at least a one (1) year guaranty, in writing, from the date of acceptance of the project, against defects. The contractor must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacement, and corrections which may be required to make good all defects in materials and/or equipment under its intended use, within the warranty period.

Section 10.0 - Permits:

The successful bidder shall obtain any and all permits required by the Jefferson Parish Department of Inspection and Code Enforcement and The City of Gretna Code Enforcement (if applicable). The successful bidder shall also be responsible for payment of these permits. All permits must be obtained prior to the start of the project

Section 11.0 - Liquidated Damages:

Commencing on the tenth day (10) following the notice to proceed until work is complete, liquidated damages will be assessed in the amount of \$100 dollars per day.

Section 12.0- Pre-Construction Conference and Notice to Proceed:




