JEFFERSON PARISH will accept one price for each item unless otherwise indicated. Two or more prices for one item will result in bid rejection. 




Model SSVB404P INFINITY UPRIGHT WINCH AND END

Removeable type, in floor sleeves. Uprights shall be single piece, 120" long and anodized 6061-T6 aluminum, 3-15/16" outside diameter weighing 23 and 29 lbs. Net shall attach at only 2 points on both winch and end post. Posts shall have integral grooved profile running entire length and single sliding rail with 2 position on-off lever locking device for slip free adjustment of heights encompassing entire length of post. Screw type locking devices shall be deemed unacceptable. Winch rail shall include permanently mounted worm drive linear actuator tightening winch and shall be low profile mechanism encased in anodized aluminum. End rail shall include J shaped hooks permanently mounted for upper and lower net attachment. Uprights shall be capable of net heights from 8'-2" to 42" to accommodate all net sports. Net shall be 9.8 meters in length and 1 meter wide. Netting shall be 10 cm square knotless nylon black mesh. Top binding shall be 50 mm woven nylon with reinforcement at corners and minimum 4 row stitching. Side binding shall be wide vinyl with wooden dowel sewn in. Wooden dowels shall be permanently fixed to top and bottom net cables allowing for tension on net from top to bottom when only corners of net are attached to post. Upper net cable to be 6mm Kevlar rope. Steel cable shall be deemed unacceptable. Bottom tension rope shall be nylon rope covered by 30mm woven nylon binding.
