Changes to Jefferson Parish Bidding Information

The Jefferson Parish Purchasing Department would like to make vendors aware of the following changes:

Total Bid Price Must Include the Cost of Naming Jefferson Parish as Additional Insured:

Bidder acknowledges that Bidder recovered the cost of any required insurance in the contract price as required by La.R.S. 9:2780.1 and that Bidder recovered any such cost for the purposes of insuring an obligation to indemnify Jefferson Parish, defend Jefferson Parish, or hold Jefferson Parish harmless and that Bidder's indemnity liability is limited to the amount of the proceeds that are payable under the insurance policy or policies that Bidder has obtained.

Electronic Procurement: Beginning November 1, 2020, Jefferson Parish will no longer accept manual bid submissions; and will only accept bid submissions electronically via our e-Procurement system, Central Bidding. Central Bidding can be accessed by visiting either www.centralbidding.com or www.jeffparishbids.net. All bidders will be required to register with Central Bidding. Per Louisiana Public Bid Law, the probable construction cost will be read at the bid opening.

SECTION 1.0 - SCOPE:

We extend this bid to cover all materials, delivery, shipping charges, and all other incidentals necessary to provide one (1) new MACHO MONSTER® Series 40002 Open Channel Electric Grinder for the Jefferson Parish Correctional Center located at 100 Dolhonde Street, Gretna, LA 70053.

SECTION 2.0 - SUBMITTALS:

The following information shall be provided with bid submission. Failure to provide the requested information with your bid will result in the bid being deemed non-responsive.

- Manufacturer's catalog data
- Detail sheets
- Specifications of product
- Warranty information
- If supplying other than specified equipment the successful bidder shall provide a scope of work to modify or replace the existing framing and support system in the wet well. (If applicable)

SECTION 3.0 – BID SPECIFICATIONS:

- At no additional cost, the successful bidder shall deliver all equipment and materials to the Jefferson Parish Department of General Services at 960 1st Street, Gretna, LA 70053.
- All Equipment shall be as specified bidder supplied new.
- The new “Open Channel Electric Grinder” shall fit into the existing framing and structural supports in the existing wet well.
- Jefferson Parish will not pay for the replacement or any modifications to the existing framing and structural supports in the existing wet well.

SECTION 4.0 – UNIT DESCRIPTION:

Grinder shall have the following:

- Grinder shall reduce or shred influent solids for protection of downstream equipment.
- Grinder shall be two-shafted design consisting of individual cutters and spacers of equal diameter on both shafts.

- Grinder shall have high flow or slotted side rails.
- Grinder shall have a motor and speed reducer for cutter drive and shall be equipped with wipes ready grinder teeth.
- Grinder shall provide peak shaft torque of 6,089 lb.-in/hp (923 Nm/kW).
- Grinder shall provide peak force at cutter tip of 1,624 lb_f/hp (9,686 N/kW).

4.1 – Cutters and Spacers Shall have the following:

- Cutting stack shall be a nominal height of 32 inches (812.8 mm).
- Cutters shall have serrated 17 teeth and be 0.438" thick and wipes ready.
- Cutters shall be heat treated to produce a hardness of 45-53 Rockwell C.
- Cutters shall have 17 cam shaped teeth. Tooth height shall not be greater than 11/16-inch (17.5 mm) above the root diameter of the cutter. OD shall be 7.50-inches (190 mm).
- Spacers shall be an individual disk constructed of AISI hardened alloy steel surface ground to a thickness of 0.884-inches +.001/-0.000 (11.3 mm +.003/-0.000).
- Spacers shall have a hardness of 34-53 Rockwell C.
- Spacers shall have a smooth outside diameter with no tooth profiles.
- Cutters shall have radial serrations on the leading edges designed to perforate material as it passes between the cutter and adjacent spacer.

4.2 – Shafts shall have the following:

- Shafts shall be AISI 4140 alloy steel with a minimum tensile strength of 149,000 PSI (1,027 kPA).
- Shafts shall measure a nominal 2-1/2 inches (63.5 mm) across flats of hex.
- Shafts shall be hardened to 38-42 Rockwell C.
- 15' extended shaft, carbon steel fabrication shall be provided on grinder.

4.3 – Seal Cartridges shall have the following:

- All seals cartridges shall be rated to a maximum of 90 PSI (620 kPA).
- All seal cartridges shall not require flushing.
- All Dynamic and rotating seal faces shall be tungsten carbide with 6% nickel binder.
- All O-rings shall be constructed of Buna-N (Nitrile).
- All Radial and axial loads shall be borne by sealed, oversized, deep-groove ball bearings.

4.4 – Housings and Covers shall have the following:

- Top cover and end housings shall be ASTM A48 gray iron.
- Bottom cover shall be ASTM A36 steel.
- End housing shall have integral bushing deflectors to guide solids away from seal cartridges.
- End housings shall have directional flow arrows cast into the external sidewalls.

4.5 – Side Rails shall have the following:

- Side rails shall be ASTM A536-84 ductile iron.
- Side rails shall have evenly spaced horizontal slots to increase flow and decrease water head loss through the grinder.
- Inside profile of the cutters shall be concave and follow the radial arc of the cutters.
- Clearance between the outside diameter of cutters and concave arc of the side rail shall not exceed 5/16-inch (7.9 mm).

4.6 – Speed Reducer shall have the following:

- Reducer shall be internal planetary mechanism with trochoidal curved tooth profile.
- Reducer shall be a vertically mounted with 43:1 single reduction.
- Reducer shall be grease lubricated.

4.7 – Motor shall have the following:

- Motor shall be 10 hp TEFC, 1725 rpm, 460-volt, 3 phase, 60 Hz.
- Motor shall have a minimum service factor of 1.15, 87.5% minimum efficiency factor at full load, minimum 77% power factor at full load.

4.8 – External Controller shall have the following:

- External controller shall provide control of the grinder and be designed to control one (1) 10 hp motor at 460 volts, 3 phase, 60 Hz.
- External controller shall have indicator lights, switches and other control devices.
- External controller enclosure shall be polyester NEMA 4X 316SS
- External controller enclosure shall house the control devices, motor starters, and PLC.
- External controller shall include a Grinder ON-OFF/RESET-REMOTE three-position 22mm type, NEMA 4X selector switch
- External controller in the OFF/RESET position, the grinder shall not run.
- External controller in the ON position, the grinder shall run continuously.
- External controller in the REMOTE position, the grinder shall start and stop as controlled by an owner supplied external device.
- External controller selector switch shall be the only method for resetting the controller after a failure.
- External controller indicator lights shall be LED type 22 mm, rated NEMA 4X.
- External controller indicator lights shall indicate POWER ON, RUN, and FAIL.
- External controller PLC shall have a minimum of 16K of memory.

- External controller Motor Starter shall be a full-voltage reversing type with 120-volt operating coils.
- External controller overload relays shall be adjustable and sized to full load amperes (FLA) of the motor.
- External controller control Transformer shall be minimum 130 VA.
- External controller control transformer primary and secondary shall be fused for over current protection.
- External controller current transducer shall have adjustable set point from 1-135A with 200 ms or less response time.
- External controller shall stop the grinder and reverse the rotation to clear an obstruction
- External controller shall stop the grinder and reverse the rotation to clear an obstruction.
- Once an obstruction is cleared, the external controller shall return the grinder to normal operation.
- If three (3) reverses occur within a 30-second interval, the external controller shall stop the grinder motor in a jam condition and activate the grinder FAIL indicator and relay.
- If a power failure occurs while the grinder is operating, the external controller will resume operation once power is restored.
- If a power failure occurs while the grinder is in a “fail” condition, the grinder shall remain in “fail” condition once power is restored.
- Grinder reset shall only be accomplished from the controller only.

SECTION 5.0 – WARRANTY:

All workmanship and materials shall have a minimum five (5) years parts and labor warranty in writing, from the date of acceptance of the project, from the manufacturer.

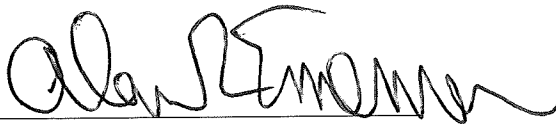

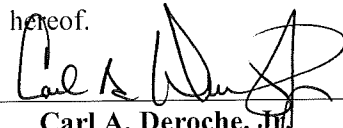
