**Section 1.0 - Site Visits:**

**Section 2.0 - Scope:**

We extend this bid for the successful vendor to provide all labor, materials, delivery, equipment and all other incidentals necessary to repair the Freight Elevator in the Jefferson Parish West Bank Water Plant located at 4500 Westbank Expressway, Marrero, LA 70072:

- Replace faulty hoist motor
- Replace coupling

**Section 3.0 - License:**

Bidder shall be required to possess a current Louisiana State Contractor's License in the Specialty Classification: Elevators, Dumbwaiters, and Escalators.

**Section 4.0 - Quantities/Inspection:**

Bidders must inspect the site and perform their own measurements in order to determine the proper quantity of materials and equipment required to complete this project.

**Section 5.0 - Standards**

Material provided shall be manufactured and installed in accordance with the ASME A17.1 Safety Code for Elevators and Escalators.

**Section 6.0 - Bid Specifications:**

- Before any work is to begin a Water Dept. representative and the successful bidder shall inspect, document, and take photos of all existing building equipment pertaining to these specifications
- All parts shall be new OEM or manufacturer approved parts.
- All work shall be performed in strict conformance with manufacturers' requirements and recommendations.
- Equipment and materials shall be installed in a neat and professional manner and shall be aligned, leveled, and adjusted for proper operation.
- The successful bidder shall verify that materials and equipment specified will fit into

the designated spaces, and which, when installed per manufacturers guidelines, will ensure a complete, coordinated, satisfactory and properly operating systems.

- After all work is completed and prior to acceptance of the project the successful bidder and Water Dept. representative shall inspect the site and verify all work is complete and the elevator is in proper working order.

**Section 7.0 - Hours of Work:**

The work that is to be performed shall be scheduled during normal working hours Monday thru Friday 6:30 a.m. thru 2:30 p.m. The successful bidder may choose to work before or after normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish. All work shall be scheduled seventy-two (72) hours in advance and shall be completed, work area cleaned, and the area ready to open for normal work activities.

**Section 8.0 - Safety Precautions:**

Safety precautions must be exercised at all times to safeguard the welfare and safety of people and property during this project.

**Section 9.0 - Warranty:**

All workmanship and materials shall have a minimum one (1) year guarantee, in writing, from the date of acceptance of the project, against defects. The Successful bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of the owner, to make changes, replacement, and corrections which may be required to make good on all defects in materials and/or equipment under its intended use, within the warranty period.

Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

---

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation. Thereafter, and prior to contract execution, the low bidder will be required to provide final insurance certificates to the Parish which shall name **the Jefferson Parish, its Districts Departments and Agencies under the direction of the Parish President and the Parish Council** as additional insureds regarding negligence by the contractor for the Commercial General Liability and the Comprehensive Automobile Liability policies. Additionally, said certificates should reflect the name of the Parish Department receiving goods and services and reference the respective Jefferson Parish bid number.

#### **☒ WORKER'S COMPENSATION INSURANCE**

As required by Louisiana State Statute, exception; Employer's Liability, Section B shall be \$1,000,000 per occurrence when Work is to be over water and involves maritime exposures to cover all employees not covered under the State Worker's Compensation Act, otherwise this limit shall be no less than \$500,000 per occurrence.

**Note:** If your company is not required by law to carry workmen's compensation insurance, i.e. not a Louisiana company, sole employee of the company, then bidders must request a workmen's compensation insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. ☒ **COMMERCIAL GENERAL LIABILITY**

Shall provide limits not less than the following: \$1,000,000.00 Combined Single Limit per Occurrence for bodily injury and property damage.

☒ **COMPREHENSIVE AUTOMOBILE LIABILITY**

Bodily injury liability \$1,000,000.00 each person; \$1,000,000.00 each occurrence.  
Property Damage Liability \$1,000,000.00 each occurrence.

Note: This category may be omitted if bidders do not/will not utilize company vehicles for the project or do not possess company vehicles. Bidder must request an automobile insurance declaration affidavit prior to the bid opening date. This insurance declaration affidavit must be fully completed, signed, properly notarized and submitted with the bid. A scanned copy of the completed, signed and properly notarized affidavit may be submitted with the bid; however, the successful bidder must submit the original affidavit in its original format and without material alteration upon contract execution. Failure to comply will result in the bid submission being rejected as non-responsive. The Parish reserves the right to award bid to the next lowest responsive and responsible bidder in this event.

**DEDUCTIBLES** - The Parish Attorney with concurrence of the Director of Risk Management have waived the deductible section of the Terms and Conditions for all Invitations to Bid, until further notice.

**UMBRELLA LIABILITY COVERAGE**

An umbrella policy or excess may be used to meet minimum requirements.

**FOR CONSTRUCTION AND RENOVATION PROJECTS:**

The following are required if selected below. Such insurance is due upon contract execution.

☐ **OWNER'S PROTECTIVE LIABILITY**

To be for the same limits of liability for bodily injury and property damage liability established for commercial general liability.

☐ **BUILDER'S RISK INSURANCE**

The contractor shall maintain Builder's Risk Insurance at his own expense to insure both the owner (Parish of Jefferson) and contractor as their interest may appear.
