**Section 4.0 - Warranty**

All equipment must have a minimum 1-year guaranty against defects. The successful bidder must agree, upon written notice from the owner, promptly and without charge, and to the satisfaction of owner, to make changes, replacement and corrections which may be required to make good all defects in equipment under its intended use, within the warranty period.
