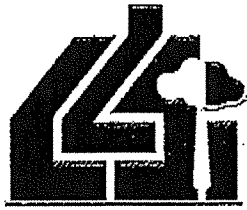

** Bring shovels, sheers, pruners, tree pruners, chain saw**

Mow and edge all turf areas.
Prune all existing plant material to an acceptable and manageable shape. Prune trees to height of 8 foot clearance. Sheer hedges on right side of building to 1 foot below windows.
Remove all oleander from beds in between sidewalk and front of building.
Remove any bushes that creates safety issues around property. Remove Pittosporum on right entry.
Fill in all holes in beds left as a result of removed material: knock dirt from root ball back into space and cover with mulch.
~~Treat all turf and landscape bed areas with Fire ant bait and pre-emergent herbicide weed~~
preverter.
Apply a minimum of two applications of post emergent weed overgrowth. Spray all cracks in parking lot.
Provide removal off site of all of the Debris trimmings, clippings and saplings made during the overhaul. Remove all existing debris i.e. fallen leaves/ weeds.
Clean out and install Organic pine straw mulch to all planting beds.
Blow all paved surfaces once completed.
