Question: On page 5 under "description of articles" it states 200-480v with pt# CL-SB-480V-100W-50K-ARM. However on a website, the voltage is 100-277v and the part number is different, but SKU numbers are the same. Can you verify the voltage needed or provide a spec sheet with part number you're requesting?

Answer: It should be 480 volts. The item should read as follows:
