Two Year contract for Annual Inspection of Di-Electric Testing for Jefferson Parish Departments and municipalities.

Contract Period: 08/06/18 – 08/05/20

To obtain an annual inspection of Jefferson Parish aerial bucket trucks for the Departments of Public Works, Traffic Engineering, and Recreation.

This contract will cover comprehensive nondestructive annual testing and inspection of all aerial units (bucket trucks) for Jefferson Parish. The request for the inspections will include visual/operational, magnetic particle, ultrasonic pin, dielectric test of boom and liner, load and acoustic emission testing.

The successful bidder will have to perform inspections at the Parish of Jefferson's maintenance facilities. The successful bidder must have all required insurances to perform and complete the required inspections. License Requirements: All copies of Insurance Certifications must be submitted with the bid.

All invoices should have unit numbers and vehicle identification numbers (VIN). All inspections should meet NSIA requirements and should be performed by an SNT-TC-1A technician in accordance with OSHA standards.

Pricing should include total cost for the afford mention testing (i.e., labor, travel and per diem).

The Purchasing Director will review it in connection with the Parish Attorney's Office as appropriate and a written response will be provided as soon as possible.

Except as where otherwise precluded by law, the Parish Attorney or his designee, with the concurrence of the Director of Risk Management or his designee, may agree on a case-by-case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date. Any changes to the insurance requirements will be reflected in the bid specifications and addenda. 
