Section 1.0 – Site Visit:

Site visits are being offered for this bid. To schedule a site visit, please get in touch with Tim Hoskins at 504-364-2675 between 8:00 a.m. and 3:00 p.m. Monday through Friday.

Section 2.0 – Scope:

We extend this proposal to provide labor, materials, equipment, transportation, and all other incidentals necessary to replace the refrigeration system on the existing walk-in cooler/freezer at the Jefferson Parish Emergency Operations and Communication Center at 910 3rd Street, Gretna, LA. 70053

Section 3.0 – License:

A Louisiana State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq., and such license number will be shown on the outside of the bid electronic envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected." A copy of the license is not required by law; however, they must specify their license number in the proper area of the electronic bid.

Section 4.0 – Quantities/Inspection:

Bidders must inspect the site and measure the proper quantity of labor, materials, and equipment required to complete this project.

Section 5.0 – Submittals:

If the bidder intends to provide materials equal to or better than owner-specified materials, the following shall be provided upon request:

- Manufacturer's catalog data.
- Detail sheets
- Specifications of the product
- Warranty information

Section 6.0 Bid Specifications:

- All materials for this project shall be bidder-supplied new.
- Remove and properly dispose of all removed equipment
- Install new freezer and refrigerator systems on the existing walk-in cooler
- Install one new Bohn condensing unit with defrost timer Model #BCH0025LCACZA0200 208/230 volt three-phase.
- Install one new pre-assembled low temperature evaporator Model # BEL0080BS6EEAB0403 208/230-volt 1 phase.
- Install one new Bohn condensing unit Model #BCH008MCACZA0000 208/230-volt 3 phases.
- Install one new pre-assembled medium temperature evaporator Model # BEL0095AS6AMAB0403 115-volt 1 phase.
- Install all new refrigerant line sets with insulation.
- New line sets shall be pressure tested with 200psi of nitrogen for 1 hour.
- New line sets shall be evacuated to 500 microns.
- New line sets shall be properly charged with R448A refrigerant.
- All electrical connections shall be properly installed per the manufacturer's guidelines.

Section 7.0 – Hours of Work:

The work to be performed shall be scheduled during normal working hours: Monday through Friday, 8:00 a.m. to 4:30 p.m.

Section 8.0 – Warranty:

One-year parts warranty from the manufacturer.

90-day labor warranty.

All warranty paperwork shall be submitted to the Department of General Services after the project.

Section 9.0 – Permits:

The successful bidder shall obtain all permits required by the Jefferson Parish Department of Inspection and Code Enforcement and the City of Gretna Code Enforcement (if applicable) and be responsible for paying for these permits. All permits must be obtained before the start of the project.

Section 10.0 – Liquidated Damages:

Commencing on the thirty-first day (31) following the notice to proceed until work is complete, liquidated damages will be assessed in the amount of \$100 per day.

Section 11.0 – Pre-Construction Conference and Notice to Proceed:

Before any work commences, a Pre-Construction Conference shall be held between the successful bidder and the owner.

No materials shall be ordered until the successful bidder receives a written “Notice to Order Materials” from the Department of General Services.

No work shall be performed until the successful bidder receives a written “Notice to Proceed” from the Department of General Services to begin work.

STANDARD INSURANCE REQUIREMENTS FOR BIDDING PURPOSES

All required insurance under this bid shall conform to Jefferson Parish Resolution No. 136353 or No. 141125, as applicable. Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or her designee, with the concurrence of the Director of Risk Management or her designee, may agree on a case-by- case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. **Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date.** Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. **Failure to comply will cause the bid to be rejected.** The current insurance certificate will be used for proof of insurance at time of evaluation.
