Additional Requirements

Requirement #3- ACKNOWLEDGED

Contractor must hold current applicable JEFFERSON PARISH licenses with the Department of Inspection and Code Enforcement. Contractor shall obtain any and all permits required by the JEFFERSON PARISH Department of Inspection and Code Enforcement. The contractor shall be responsible for the payment of these permits. All permits must be obtained prior to the start of the project.

Contractor must also hold any and all applicable Federal and State licenses. Contractor shall be responsible for the payment of these permits and shall obtain them prior to the start of the project.

➤ Requirement #4- Attached as document

A LA State Contractor's License will be required in accordance with LSA R.S. 37-2150 et. seq. and such license number will be shown on the outside of the bid electronic envelope. Failure to comply will cause the bid to be rejected. When submitting the bid electronically, the license number must be entered in the appropriate field in the electronic procurement system. Failure to comply will cause the bid to be rejected.

➤ Requirement #5- VISITED 10/05; arranged w/ Tim Hoskins

It is the bidder's responsibility to visit the job site and evaluate the job before submitting a bid.

➤ Requirement #6- ACKNOWLEDGED

Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Flammable material must be removed from the job site daily because storage will not be permitted on the premises.

Precaution must be exercised at all times to safeguard the welfare of JEFFERSON PARISH and the general public.

➤ Requirement #10- INSURANCES & AFFIDAVIT ATTACHED

All bidders must comply with the requirements stated in the attached "Standard Insurance Requirements" sheet attached to this bid solicitation. Failure to comply with this instruction will result in bid rejection.

Requirement #11- Submitted w/ bid

A bid bond will be required with bid submission in the amount of 5% of the total bid, unless otherwise stated in the bid specifications. All sureties must be in original format (no copies). When submitting a bid online, vendors must submit an electronic bid bond through the respective online clearinghouse bond management system(s) as indicated in the electronic bid solicitation on Central Auction House. No scanned paper copies of any bid bond will be accepted as part of the electronic bid submission.

➤ **Requirement #13- ACKNOWLEDGED**

Freight charges should be included in total cost when quoting. If not quoted FOB DELIVERED, freight must be quoted as a separate item. Bid may be rejected if not quoted FOB DELIVERED or if freight charges are not indicated on bid form.

Evaluation/Bid Specifications

- All materials shall be bidder supplied new.
- Design, engineer, supply, and install one new partition wall on the 2nd floor of the Thomas Donelon Building.
 - Hight and materials shall match the existing walls.
 - Wall must be insulated.
 - Sheetrock shall be fire-rated to match existing building materials.
- All materials shall be installed as per manufacturer recommendations and guidelines.
 - Prime and paint the new wall to match the existing walls.
- Create two (2) new door openings. Locations will be provided to bidders at the site visit.
- Furnish and install two (2) new doors to match the existing doors.
 - Install a level 5 drywall finish to all Gypsum drywall.
- Supply and Install two (2) new Corbin Russwin door locksets with cores. The owner will have the bidder-supplied cores keyed.

Dates and Times

As per Sections 8 & 13, The work to be performed shall be scheduled during regular working hours Monday through Friday, 7:30 a.m. through 4:30 p.m.; bidder may choose to work before or after normal building working hours to provide a safe work environment at no extra charge to Jefferson Parish. All work shall be scheduled seventy-two (72) hours in advance and shall be completed, the work area cleaned, and the area ready to open for the next business day. A "Start of Work Conference" shall be held between the successful bidder and the owner before any work commencing. No Materials shall be ordered until the successful bidder receives a written "Notice to Order Materials" from the Department of General Services. No work shall be performed until the successful bidder receives a written "Notice to Proceed" to begin work from the Department of General Services.
