All bids submitted are subject to these instructions and general conditions and any special conditions and specifications contained herein, all of which are made part of this bid proposal reference. By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 113646 and/or Resolution No. 113647.

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.

All vendors submitting bids should register as a Jefferson Parish vendor if not already yet registered. Registration forms may be downloaded from <http://purchasing.jeffparish.net> and by clicking on Vendor Information. Current W-9 forms with respective Tax Identification numbers and vendor applications may be submitted at any time; however, if your company is not registered and/or a current W-9 form is not on file, vendor registration is mandatory. All quotations shall be based on F.O.B. Agency warehouse or job site, anywhere within the Parish as designated by the Purchasing Department. This provision does not apply to public works projects

JEFFERSON PARISH requires all products to be new (current) and all work must be performed according to standard practices for the project. Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

Bidders should submit all questions in writing via email to the buyer's email address as indicated above, no later than Five (5) working days prior to the bid opening. Bid numbers should be mentioned in all requests. If submitting online, vendors may send questions via the E-Procurement site no later than Five (5) working days prior to the bid opening.

A. AWARD OF CONTRACT: JEFFERSON PARISH reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of JEFFERSON PARISH. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.

All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar days.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)

PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. "LSA - R.S. 38:2251-2261"

B. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. D. PRICES: Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and Parish taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Questions and Answers:

Question 1: Page 8; section 5: The SS enclosure wanted for the electric air compressor has an inadequate spec. design since is very vague in its description. More description details will be needed if expected to assure offering of such enclosure is adequate for the project, otherwise we will need to offer what we think is wanted. Our offering will be a minimum design to meet such spec. intent. There are (2) design thoughts for offering a SS enclosure. Obviously, there is a considerable cost difference between the designs of just a drop over enclosure over the base mounted package verses one having a floor and unit mounted inside the enclosure. This maybe a disappointment when we make such offer as currently least costly of the drop over enclosure and may not be considered acceptable toward what is expected. Being a public bid, the law only requires that we meet the letter of the spec. requirement as a design build intent. Will offer our description on a separate letterhead for such description as surprisingly evident that it will need to be accepted as long as it meets what is called for, when we make the bid offering. The enclosure material is not specified as to whether 304 or 316 SS and thickness of metal should be specified. Our envisioning the supply of a drop over enclosure that will be bolted to the concrete slab by parish or an independent contractor is to be provided. Currently, this enclosure would have louvers on side, front, and back and exhaust fan out the top. Would have a double door to handle servicing of the compressor pkg. Would be weatherproof with a 24" fan cover of aluminum as used on house roofs for design. Electric motor would be drip proof open type with an interlock when compressor runs, fan runs. Lifting eyes in each corner to lift enclosure should major repairs need to be made. Clarify exact design wanted by addendum so we are assured what we are considering, is what is desired.

Starter package in nema 1 enclosure as supplied by factory as mounted on base. All wiring by others to various points on compressor. Power source as 120V and 460V needed for controls and power.

Answer: The enclosure is intended to have a base floor with the unit mounted inside. The material composition should be 316 Stainless Steel, .125" thickness. The enclosure would have louvers on all sides and an exhaust fan on the roof housing. The enclosure should come equipped with doors to provide adequate access to the unit for service work. The exhaust fan should be set to run when the compressor runs. Lifting lugs are required on each corner of the base. NEMA 4 starter is required. Immersion heater would be used.

Question 2: The diesel driven air compressor as noted on page 6 as section 2. has same issue of enclosure design description. This unit also has air needing to be exhausted out of the enclosure and no fan is indicated. Design would be similar as a drop over enclosure with double door and intake louvers. Again, clarify exact design wanted by addendum.

Answer: The enclosure should include an exhaust fan on the roof housing. The exhaust fan should be set to run when the compressor runs. Air intake would be extended to outside of both packages.

Question 3: Per section 1, page 1 thru 5: We see that on page 4, item 22, the crank case heater is specified. Gardner Denver Champion mfg. has stated that this is not possible to supply. Only a crank case heater block heater or blanket can be supplied. Clarify which is wanted. Heater will need to be cut off when compressor operates, thus an interlock circuit within panel needed. On page 3, under aftercooler description, stating that an oil coolant gauge is needed. This should be an air coolant gauge.

Answer: An air coolant gauge should be provided in place of an oil coolant. A crank case block heater should be supplied. The immersion heater should be wired so that it is not in operation while the compressor is running.

- A complete specification and submittal of all major components for the proposed air compressors.
- Information and specifications for the electrical controls and control panel.
- One certified copy of installation and operation manuals for the compressor package.
- One copy of oil pump "Bill of Materials" of the unit's construction, cutaway drawings, and dimensions as offered to confirm compliance with the specifications.
- One descriptive brochure showing photographs and/or describing the pump unit.

In accordance with the specifications originally issued and (3) addendums for modification of the specs., we are offering that as noted for requirement intent. We are offering a further descriptive summary to establish clarity and understanding of what is being offered to meet such intent interpretation. We are also offering a revision to 2 HP TEFC motor instead of 3 HP indicated for the transfer pumps since the Flowserve pump bracket is set up for accommodating a frame 182 or 184TC motor as noted in specs. The 3 HP motor has a frame 213TC and way over-sized for the application as shown on the performance curve for 17 GPM at 30 PSI. Actual HP draw is 1.3 HP with liquid being pumped at pressure shown at 1150 RPM speed.

As for the compressor units, we are offering the J.A. Controls duplex and simplex panels for project and their quality for custom built reliable application. Factory on the simplex is not able to offer exactly what we assume is required as interpreted as a simplex design panel with status lights and sensors on compressor pump shown in specs. Panel also powers the compressor block heaters for both simplex indoor and outdoor SS enclosure units as asked for in addendum #3 for such packages design arrangement. We are assuming that what is noted for features of the duplex compressor packaged description, also applies for the simplex packages, even though we are seeing limited design requirements for a mounted starter only provision. We are mounting and wiring the simplex starter panel on each skid package and pre-wired to all components in package. Same with the diesel driven compressor package for a working application. All compressor units as required are ready for operation once installed at pump station and minor wiring and piping to each being accomplished after installation.

We advise that the duplex air compressor pkg. has a pro-rated 5 year warranty specified. This is no longer available from the factory as a std. warranty. We have added a special warranty kit for a 6 year pro-rated warranty now available instead of the std. 3 year. This supplies synthetic oil and added oil filters with a quantity of oil for change out on a regular basis. Not offered with the other packages since the std. 3 year is asked for. The rest of the equipment covers 1 year std. limited warranty for motor,

switches, and panel on all packages. See 3 year warranty for description supplied here-in and the old 5 year warranty.
